Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney Thomas Martin and Clerk to Council Elizabeth G. Hulse present.

Ordinance 2014-22 [in title only] "AN ORDINANCE TO AMEND OCONEE COUNTY ORDINANCE 2014-01, THE BUDGET ORDINANCE FOR OCONEE COUNTY FOR THE FISCAL YEAR BEGINNING JULY 1ST, 2014 AND ENDING JUNE 30TH, 2015, IN CERTAIN LIMITED REGARDS AND PARTICULARS, ONLY, SO AS TO INCLUDE A PROVISO FOR DISBURSEMENT OF CERTAIN FUNDS; AND OTHER MATTERS RELATED THERETO"

Mr. Corbeil made a motion, seconded by Mr. Cain, approved 5 - 0, to approve **Ordinances 2014-22** on first reading in title only.

Discussion Regarding Action Items:

Oconee County Millage for Tax Year 2014

Mr. Ken Nix, Oconee County Auditor, addressed Council utilizing a PowerPoint presentation [copy filed with these minutes] and a handout [copy filed with these minutes] regarding his recommendation for millage for tax year 2014 for Oconee County, SDOC and the Keowee Fire Special Tax District as follows:

Oconee County: 73.9 mills

SDOC Operations: 111.1 mills [total 142.1 mills with bond millage]

Keowee Fire Special Tax District: 14.5 mills

Lengthy discussion followed. Mr. Corbeil stated he felt that Council should "hold the line on taxes" based on several variables include future funding of the LGF, Act 388, infrastructure needs, etc. Mr. Cain, Mr. McCall & Mr. Dexter concurred noting that the mill value needs to continue to be increased rather than increasing the millage.

Mr. Corbeil made a motion, seconded by Mr. McCall, approved 4 - 1 [Mr. Thrift opposed] to hold millage at the current levels as outlined below:

Oconee County: 73.9 mills

SDOC Operations: 110.1 mills [total 141.1 mills with bond millage]

Keowee Fire Special Tax District: 14.5 mills

Old Business:None at this meeting.

Mr. McCall made a motion, seconded by Mr. Dexter, approved 5-0 to defer this matter indefinitely in order to solicit additional questionnaires to fill this seat.

Mr. Cain made a motion, seconded by Mr. Corbeil, approved 5-0 to enter Executive Session for the purpose of discussing several Economic Development matters and a contractual matter.

Council entered Executive Session at 6:53 p.m.

Council returned from Executive Session at 9:58 p.m. on a motion by Mr. Corbeil, seconded by Mr. Cain, approved 4-0.

Mr. Corbeil made a motion, seconded by Mr. Cain, approved 4-0 to authorize the County Administrator and Economic Development Staff to continue negotiations regarding the various Economic Development matters as discussed in Executive Session.
