Mr. Corbeil made a motion, seconded by Mr. Dexter, approved 5 - 0 to approve **Ordinance 2014-23** on third & final reading.

Ordinance 2014-24 "AN ORDINANCE AUTHORIZING AND DIRECTING THE PROVISION OF COUNTY-FUNDED LEGAL REPRESENTATION, DEFENSE, AND LIMITED INDEMNIFICATION FOR OCONEE COUNTY EMPLOYEES IN CERTAIN LIMITED CIRCUMSTANCES INVOLVING THE DIRECTION AND PERFORMANCE OF OFFICIAL DUTIES; AND OTHER MATTERS RELATED THERETO"

Mr. Corbeil made a motion, seconded by Mr. Dexter to approve **Ordinance 2014-24** on third & final reading. Mr. Thrift asked Mr. Martin to address the specifics of the ordinance and the Attorney General opinion received [copy filed with these minutes].

In summary, Mr. Martin stated the following:

- Insurance Reserve Fund [IRF] has stated that this ordinance will not impact coverage for county employees
- Ethics Commission in their informal opinion [copy filed with these minutes] stated that Council members are not prohibited from voting on this ordinance as they are part of the large group
- Attorney General stated that in their opinion the ordinance is legal, however they requested clarification in several areas

Mr. Martin read the conclusion from the Attorney General opinion into the record and recommended to Council that the changes be made and the ordinance amended. Lengthy discussion followed.

Mr. Thrift suggested tabling the ordinance to allow the attorney time to amend based on discussions. Additionally, Mr. Thrift suggested after passage of the ordinance that Council look at potentially adding specific boards, commissions and or committees but to not take this action at this time. Discussion followed.

Mr. Corbeil made a motion, seconded by Mr. Cain, approved 5 - 0 to [1] direct the County Attorney to make the suggested changes from the Attorney General, and [2] to table this ordinance to allow the attorney to draft an amended ordinance for consideration by Council at the December 2, 2014 meeting.

Second Reading of the Following Ordinances

Mr. Corbeil made a motion, seconded by Mr. Cain, approved 5 - 0 to approve **Ordinance 2014-26** on second reading.

Ordinance 2014-28 "AN ORDINANCE AMENDING CHAPTER 32 AND CHAPTER 38 OF THE OCONEE COUNTY CODE OF ORDINANCES, IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, REGARDING HEIGHT RESTRICTIONS FOR STRUCTURES LOCATED IN ZONED INDUSTRIAL DISTRICTS AND FOR STRUCTURES LOCATED IN AREAS DESIGNATED BY OCONEE COUNTY AS COUNTY INDUSTRIAL PARKS; AND OTHER MATTERS RELATED THERETO."

Mr. Moulder noted that the Planning Commission, in response to the posting of the Council agenda, reviewed **Ordinance 2014-28** at their December 17, 2014 meeting and have provided a written recommendation [copy filed with these minutes] for Council's consideration; therefore, Council does not need to forward to the Planning Commission as advertised on the agenda.

Mr. McCall made a motion, seconded by Mr. Dexter, approved 5 - 0 to approve **Ordinance 2014-28** on first reading.

Mr. Thrift made a motion, seconded by Mr. McCall, approve 4 - 1 [Mr. Dexter opposed] to Direct Administrator to provide Cost Benefit Analysis [CBA] for leasing of vehicles and to identify City of Seneca's willingness to establish a trial period for routes to ID need/ridership.

Mr. Thrift called for the vote on the matter as amended. The motion passed 4 - 1 [Mr. Dexter opposed].

Professional Services / Davis & Floyd / Road Improvements Stone Pond Subdivision / \$318,865

Mr. Thrift questioned if the property owners were aware of the cost of these services as they exceeded our original estimates. Mr. Moulder assured Council that all parties are aware and that once the work begins that they are responsible for reimbursement even if the project is not completed.

Mr. Dexter made a motion, seconded by Mr. Corbeil, approved 5 - 0 to approve the not to exceed professional services fee of \$318,865.00 to Davis & Floyd, Inc., of Greenwood, SC.

RFP 14-05 / Road Assessment Services / \$127,853.66

Mr. Dexter made a motion, seconded by Mr. McCall, approved 5 - 0 to award of RFP 14-05, Road Assessment Services, to Transmap Corporation of Upper Arlington, OH in the amount of \$127,853.66.

Mr. John Powell addressed Council stating the following:

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5 - 0 to move forward to accept proposals from interested entities for the old courthouse restoration project and forward matter to Real Estate, Facilities & Land Management Committee for further discussion and recommendation.
