Seven [7] Chevrolet Tahoe's / Sheriff's Office / \$204,903

Mr. Moulder and Ms. Robyn Courtright, Procurement Director, addressed Council regarding this matter.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to approve purchase of seven Chevrolet Tahoes to Love Chevrolet, of Columbia, SC, in the amount of \$204,903.00, per State Contract # 4400009456.

Old Business:

Transit Advisory Task Force Committee Recommendation to Council

Mr. Moulder stated that he had talked to the City of Seneca who are willing to use a spare bus to initiate a trial program to be run five days a week for approximately six months to identify need and ridership. Additionally, he noted that public education regarding the trail period will need to be done prior to initiating any routes.

Grant Write Position / Job Share with School District

Mr. Dexter questioned Mr. Moulder to identify if the part time employee at the school district would be willing to be full time to allow the county to job share her position. The employee did not wish to go full time; therefore, Mr. Moulder stated that he is exploring other options to include an external company such as ECIVIS who would work with county staff to find and write grants and/or recommending in the FY2015-2016 budget funding a full time position for the county.

Mr. Cain made a motion, seconded by Mr. McCall, approved 5 - 0 to direct the Administrator to work with Mr. Markovich & Mr. Witter to draft a proposal regarding the business relationship between the parties, to identify potential costs and entity funding and to develop a master redevelopment agreement for Council's approval.

Mr. Cain made a motion, seconded by Mr. McCall, approved 5 - 0 to direct the Administrator and/or County Attorney to draft an ordinance to convey interest in the Old Coroner Building to the Cherokee Museum for purposes consistent with their mission and with the understanding

that they will work with Patriot's Hall and the Oconee Heritage Museum to potentially share storage space in the building.

Mr. Corbeil made a motion, seconded by Mr. Cain, approved 5 - 0 to direct that the County Owned/Abandoned Property Policy be placed on the January 6, 2015 agenda for Council's consideration.
