## OCONEE COUNTY COUNCIL MEETING Regular Meeting May 5, 2015

Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney Thomas Martin and Elizabeth G. Hulse, Clerk to Council present.

Mr. McCall called the meeting to order at 6:00 p.m.

Mr. Samuel Rankin addressed Council regarding an animal control issue.

Ms. Janet Barwick, Humane Society Board Member, thanked Council for funding FY 2015-2016 as proposed in the Administrator's budget.

Mr. Redd Gardner addressed Council in opposition to Economic Development's promotional video for the Oconee Industry & Technology Park.

Mr. Marty Hurst addressed Council regarding questions related to Ordinance 2015-14.

Mr. Bill Caster, Library Board Member, addressed Council in support of a new Seneca branch library and promoted the Sheriff's Office Citizen Police Academy.

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5-0 to approve **Proclamation P2015-05** on first & final reading. Sheriff Mike Crenshaw was present to accept the proclamation.

## **Board / Commission Appointments**

### Scenic Highway Committee / 1 At Large Seat

At Large: Ms. Cammick made a motion, seconded by Mr. Cain, approved 5 – 0 to appoint Mr. Scott Lusk to an At Large Seat on the Scenic Highway Committee.

#### Conservation Bank Board / Charitable Corp. or Trust Candidate

At Large: DEFERRED

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5 - 0 to [1] table appointment of the At Large Seat indefinitely, and [2] to direct the County Attorney draft an ordinance to amend the board's membership requirements; making them less stringent as requested by the Board.

## **Executive Session**

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5-0 to enter into Executive Session for the purpose if discussing a litigation matter.

Council entered Executive Session at 7:11 p.m.

Council returned from Executive Session upon a motion by Mr. Cain, seconded by Mr. Thrift, approved 5-0 at 8:09 p.m.

Mr. Cain noted that two members left Executive Session prior to discussion conclusion [Mr. McCall & Ms. Cammick] and that no action was taken in Executive Session.

Mr. Cain made a motion, seconded by Mr. Thrift to direct the Administrator to direct the County Attorney to remove the litigation matter from the docket as discussed in Executive Session.

Ms. Cammick made a substitute motion, seconded by Mr. McCall, defeated 2-3 [Mr. Cain, Mr. Thrift & Mr. Dexter opposed] to adopt the agreement as presented.

Discussion followed

Mr. Cain called for the vote on the main motion.

The motion passed 3-2 [Mr. McCall and Ms. Cammick opposed] to direct the Administrator to direct the County Attorney to remove the litigation matter from the docket as discussed in Executive Session.

Ms. Cammick made a motion, seconded by Mr. McCall, defeated 2-3 [Mr. Cain, Mr. Thrift & Mr. Dexter opposed] to rescind Ordinance 2014-24 "An Ordinance authorizing and directing the provision of county-funded legal representation, defense, and limited indemnification for Oconee County employees in certain limited circumstances involving the direction and performance of official duties; and other matters related thereto".
