

MINUTES OCONEE COUNTY COUNCIL MEETING Regular Meeting August 18, 2015

Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder and County Attorney Thomas Martin present.

Call to Order

Mr. McCall called the meeting to order at 6:00 p.m.

Public Comment Session

Mr. Cain made a motion, seconded by Mr. Thrift, to approve **Ordinance 2015-18** on third and final reading.

Discussion followed.

The motion failed 0-5, with all members of Council dissenting.

There was consensus among Council to try and schedule a workshop with public input for September 8 regarding the noise ordinance.

Mr. Cain made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve **Ordinance 2015-20** on third and final reading.

Ordinance 2015-22 "AN ORDINANCE **CANCELLING, REVOKING, AND RESCINDING OCONEE COUNTY ORDINANCE 2014-24** AND ITS SUBSEQUENT CODIFICATION; AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Ms. Cammick, approved 3 - 2 [Mr. Dexter & Mr. Thrift opposed] to approve **Ordinance 2015-22** on third and final reading.

Second Reading of the Following Ordinances

Ordinance 2015-23 "AN ORDINANCE TO AMEND CHAPTER 2, ARTICLE IV, DIVISION 8 OF THE CODE OF ORDINANCES OF OCONEE COUNTY PERTAINING TO THE **CAPITAL PROJECTS ADVISORY COMMITTEE**; AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve **Ordinance 2015-23** on second reading.

First Reading of the Following Ordinances

Ordinance 2015-24 [title only] "AN ORDINANCE TO AMEND SECTION 2-191. "APPOINTMENT; DUTIES" OF DIVISION 4. "**COUNTY ATTORNEY**" OF ARTICLE III. "OFFICERS AND EMPLOYEES" OF CHAPTER 2. "ADMINISTRATION" OF THE OCONEE COUNTY CODE OF ORDINANCES; AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Ms. Cammick, to approve **Ordinance 2015-24** on first reading in title only.

Discussion followed. There was consensus among Council for the draft ordinance to be prepared in a manner to reflect that the county attorney would report to the county administrator. The motion passed 3 - 2 [Mr. Thrift and Mr. Dexter opposed].

Ordinance 2015-25 [title only] "AN ORDINANCE AMENDING CHAPTERS 32 AND 38 OF THE OCONEE COUNTY CODE OF ORDINANCES IN CERTAIN LIMITED REGARDS AND PARTICULARS PERTAINING TO OCONEE COUNTY HEIGHT STANDARDS, ONLY; AND OTHER MATTERS RELATED THERETO"

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve **Ordinances 2015-25** on first reading in title only.

Ordinance 2015-27 "AUTHORIZING THE EXECUTION AND DELIVERY OF AN EQUIPMENT LEASE-PURCHASE AGREEMENT IN THE AMOUNT OF NOT EXCEEDING \$4,200,000 TO DEFRAY THE COSTS OF ACQUIRING VARIOUS EQUIPMENT; AND OTHER MATTERS RELATING THERETO"

Mr. Cain made a motion, seconded by Ms. Cammick, approved 5 - 0 to approve **Ordinances 2015-27** on first reading.

First Reading of the Following Resolutions

Resolution R2015-13 "A RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF A REVISED OPERATING AGREEMENT BETWEEN AND AMONG THE OCONEE COUNTY HUMANE SOCIETY, INC., THE OCONEE COUNTY SHERIFF, AND OCONEE COUNTY, PERTAINING TO OPERATIONS AT THE OCONEE COUNTY ANIMAL SHELTER; AND OTHER MATTERS RELATED THERETO"

Mr. Dexter made a motion, seconded by Mr. Cain, approved 5 - 0, to table the matter until the September 1^{st} meeting of Council.

Resolution R2015-14 "A RESOLUTION AUTHORIZING THE EXECUTION AND DELIVERY OF A REVISED OPERATING AGREEMENT BETWEEN AND AMONG THE OCONEE COUNTY HUMANE SOCIETY, INC., THE OCONEE COUNTY SHERIFF, AND OCONEE COUNTY, PERTAINING TO OPERATIONS AT THE OCONEE COUNTY ANIMAL SHELTER; AND OTHER MATTERS RELATED THERETO"

Ms. Cammick made a motion, seconded by Mr. Cain, approved 5 - 0, to approve **Resolution R2015-14** on first and final reading.

Discussion Regarding Action Items

RFP 12-15 / Construction Project Continuation / Not to Exceed \$200,000 / Broadband Project FOCUS

Mr. Dexter made a motion, seconded by Mr. Cain, approved 5 - 0 to approve the continuation of the award for construction work relating to Broadband projects to GeoVision of Sylva, NC for a not-to-exceed amount of \$200,000 for FY 2015-2016.

Landfill Compactor / Solid Waste / \$585,702.68

Mr. Cain made a motion, seconded by Mr. Dexter, approved 5 - 0 to approve

[1] the purchase of a BOMAG Landfill Compactor from Road Machinery Services, Inc., of Statesville, NC, in the amount of \$\$585,702.68, per the NJPA Contract,

[2] approve the issuance of a Letter of Intent to order the new compactor, and

[3] approve the separate trade-in of the existing 826G landfill compactor to Road Machinery Services.

RFP 14-15 / Tanker Fire Truck / Cross Roads Fire Department / \$226,500

Mr. Dexter made a motion, seconded by Mr. Cain, approved 5 - 0 to approve the award of RFP 14-15 for a Tanker Fire Truck for Cross Roads Rural Fire Station 13 to Fouts Brothers Fire Equipment of Smyrna, GA in the amount of \$226,500.

Council Committee Reports

Budget, Finance & Administration Committee / Ms. Cammick

The committee report was moved to the September 1st meeting of Council as Ms. Cammick left to meeting due to personal matter.

Old Business:

Economic Development Property/Walhalla

Mr. Thrift made a motion, seconded by Mr. Cain, approved 4 - 0, to direct the Administrator to move forward with holding an absolute or live auction, in regards to the Economic Development Commission property in Walhalla.

New Business:

None discussed at this meeting.

Executive Session:

Mr. Cain made a motion, seconded by Mr. Dexter, approved 4 - 0 to enter Executive Session as allowed for in §30-4-70 (a) of the Code of Laws of South Carolina, as amended, 1976 for the purpose of:

[1] discussion regarding potential land acquisition for the Rock Quarry.

[2] discussion regarding pending litigation related to Oconee County v Hanger III, et. al., and

[3] discussion of a pending litigation matter related to the MP2Net v. Oconee County.

Council entered Executive Session at 8:10 p.m.

Council returned from Executive Session at 8:44 p.m. on a motion by Mr. Dexter, seconded by Mr. Cain, approved 4 - 0.

Mr. McCall stated that no action was taken in Executive Session.

Mr. Cain made a motion, seconded by Mr. Thrift, approved 4 - 0 to direct the Administrator to negotiate purchase contract for property near the Oconee County Rock Quarry as discussed in Executive Session.
