Mr. McCall called for the vote on **Ordinance 2015-31** as amended. The motion as amended passed 5-0.

Mr. Dexter made a motion, seconded by Ms. Cammick, approved 5-0 to approve **Ordinance 2015-28** on second reading.

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5-0 to approve **Ordinance 2015-32** on second reading.

Ordinance 2015-33 "AN ORDINANCE AMENDING OCONEE COUNTY ORDINANCE 2015-01 IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, BY TRANSFERRING \$700,000 BETWEEN FUNDS AND BY AMENDING REVENUE NUMBERS, AND AUTHORIZING THE PURCHASE OF CERTAIN REAL PROPERTY (PATILLO PURCHASE); AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Ms. Cammick, to approve **Ordinance 2015-33** on third and final reading.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5-0 to amend **Ordinance 2015-33** as follows:

- \$150,000 transfer from the Tri-County Technical College to Library Improvements, and
- Remove \$150,000 from the Tri-County Technical College Revenue line item.

Mr. McCall called for the vote on **Ordinance 2015-33** as amended. The motion as amended passed 5-0.

First Reading of the Following Ordinances

Ordinance 2015-34 [title only] "AN ORDINANCE AUTHORIZING A FEE-IN-LIEU-OF-TAX ARRANGEMENT ON BEHALF OF PROJECT MACKINAW ("COMPANY") PURSUANT TO A FEE-IN-LIEU-OF-TAX AGREEMENT BETWEEN OCONEE COUNTY, SOUTH CAROLINA ("COUNTY") AND THE COMPANY; AUTHORIZING THE CONVEYANCE OF CERTAIN REAL PROPERTY; AND OTHER MATTERS RELATING TO THE FOREGOING"

Mr. Dexter made a motion, seconded by Ms. Cammick, approved 5-0 to approve **Ordinance 2015-34** on first reading in title only.

Council Committee Reports

Transportation Committee / Mr. Thrift

Mr. Thrift read from a prepared statement [copy filed with these minutes] highlighting discussions at the October 13, 2015 committee meeting.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5-0 to affirm the Committee's recommendation that Council will to the Fendley's request for abandonment; noting that Council will be required to pass a resolution.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5-0 to affirm the Committee's recommendation [1] that staff work with the county attorney to develop draft language to address sub-standard road where right of ways exist, and [2] to report back to the Transportation Committee at a future meeting.

Budget Committee / Ms. Cammick

Ms. Cammick read from a prepared statement [copy filed with these minutes] highlighting discussions at the October 13, 2015 committee meeting.

Board / Commission Appointments

Board of Zoning Appeals

Mr. Dexter made a motion, seconded by Mr. Cain, approved 5-0 to appoint Mr. W. John Menzies to the District V Board of Zoning Appeals open seat; noting the term is co-terminus with the District V Council seat.

Old Business:

Recycling Program Update

Mr. McCall requested an update from Mr. Moulder regarding the status of the recycling program. Mr. Moulder noted that he is working with Clemson University to identify ways to partner with them and he is working on an industrial cardboard hauling program and will be meeting with the County Industrial Group this week. Lastly, he noted again that significant resources will need to be identified and in place to meet the goal of 85% county wide recycling.

Nuisance Property Ordinance Update

Mr. Dexter requested an update from Mr. Moulder regarding this issue. Mr. Moulder noted that staffing is an issue along with state law restrictions regarding cost recovery from problem properties. The property maintenance code prohibits the county from recovering costs associated with enforcement. Mr. Thrift noted that SCAC is currently supporting a bill that would allow counties to recover costs as municipalities do.

New Business:

Long Creek Community Club Request for County Assistance

Mr. Thrift provided a copy of a letter to all council members [copy filed with these minutes] outlining the Clubs request for county assistance in developing a walking track. Discussion followed.

Mr. Thrift made a motion, seconded by Mr. Cain, approved 5-0 to instruct the Administrator to provide assistance to the Long Creek Community Club as outlined in their letter utilizing the county's Road Department.

Sheriff Deputy Retention

Mr. Cain stated that he has been made aware that up to 5 county sheriff's deputies will leave the department by year end due to low salaries. Mr. Moulder questioned if Council had a funding mechanism in mind to address these concerns. Mr. Thrift stated that once the plan is developed that Council will look at funding options. Discussion followed.

Mr. Cain made a motion, seconded by Mr. McCall, approved 5-0 to direct the Administrator work with Sheriff Crenshaw to identify short term and long term retention strategies to address the ongoing loss of deputies due to low pay.

Executive Session:

Mr. Cain made a motion, seconded by Ms. Cammick, approved 5-0 to enter Executive Session as allowed for in §30-4-70 (a) of the Code of Laws of South Carolina, as amended, 1976 for the purpose of:

- [1] discussion regarding pending litigation related to Oconee County v Hanger III, et. al., and
- [2] discussion regarding an Economic Development matter: specifically Project Endurance.

Council entered Executive Session at 8:18 p.m.

Council returned from Executive Session at 8:36 p.m. on a motion by Mr. Cain, seconded by Mr. Thrift, approved 4-1 [Mr. Dexter opposed].

Mr. McCall stated that no action was taken in Executive Session.

Mr. Cain made a motion, seconded by Ms. Cammick, approved 5-0 to direct the Administrator to proceed with the purchase option extension related to Project Endurance as discussed in Executive Session.
