Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root and Elizabeth G. Hulse, Clerk to Council present.

Mr. McCall called the meeting to order at 6:01 p.m.

Ordinance 2015-28 "AN ORDINANCE TO AMEND CHAPTER 38 "ZONING" OF THE OCONEE COUNTY CODE OF ORDINANCES, INCLUDING ALL ZONING MAPS INCORPORATED THEREIN AND THEREBY, IN CERTAIN LIMITED REGARDS AND PARTICULARS, ONLY; AND OTHER MATTERS RELATED THERETO" [Gardiner Group PDD]

Mr. McCall opened the floor for Public Comment.

Noting that no citizens signed up to address Council; Mr. McCall opened the floor for any citizen wishing to address Council regarding this ordinance.

Ms. Andy Heller addressed Council in support for Ordinance 2015-28 and the PDD but asked Council remove language overriding the existing lake overlay.

Pastor Daniel McCall, Issaquena Church of God, addressed Council in opposition to passage of Ordinance 2015-28 for religious reasons based on proximity to their church.

Ms. Tonya McCall addressed Council in opposition to passage of Ordinance 2015-28 for religious reasons.

Mr. Ben Turetzky addressed Council in support for Ordinance 2015-28 but asked that language related to storm water be strengthened.

Ordinance 2015-33 "AN ORDINANCE AMENDING OCONEE COUNTY ORDINANCE 2015-01 IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, BY TRANSFERRING \$700,000 BETWEEN FUNDS AND BY AMENDING REVENUE NUMBERS, AND AUTHORIZING THE PURCHASE OF CERTAIN REAL PROPERTY (PATILLO PURCHASE); AND OTHER MATTERS RELATED THERETO"

Mr. Cain made a motion, seconded by Mr. Thrift, to approve **Ordinance 2015-33** on third & final reading.

Council reiterated for the public and the record their intent to provide land only for a permanent location for the Heritage Fair and Farmer's Market; that the group is responsible for developing the plan for the facility, identifying funding and ultimately the operation of the facility. Council stated its intent to assist with grant writing but noted that it is the intent of Council that the county not construct facilities of any type for the project.

Mr. McCall called for the vote.

The motion passed 5 - 0 to approve **Ordinance 2015-33** on third and final reading.

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5-0 to approve **Ordinance 2015-34** on second reading.

Resolution R2015-16 "A RESOLUTION IDENTIFYING PROJECT MACKINAW TO SATISFY THE REQUIREMENTS OF SECTION 12-44-40; COMMITTING TO ENTER INTO SUCH NECESSARY AGREEMENTS TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND OTHER MATTERS RELATED THERETO"

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5-0 to approve **Resolution R2015-16** on first & final reading.

Discussion Regarding Action Items

Arts & Historical Grants / \$28,496

Mr. Cain made a motion, seconded by Mr. Dexter, approved 5-0 to approve the Arts & Historical grants as presented.

Local ATAX / up to \$20,000 / 2016 FLW College National Championship Fishing Tournament

Mr. Cain made a motion, seconded by Mr. Thrift, approved 5-0 to approve up to \$20,000 from local ATAX to host 2016 FLW College National Championship on Lake Keowee in March 2016.

Old Business:

None discussed at this meeting.

New Business:

Planning Commission Recommendation / Capital Improvement Listing [CIP v2015-01]

Mr. Cain made a motion, seconded by Ms. Cammick, approved 5-0 to receive the Capital Project Improvement List [CIP v2015-1], containing the Pending Project List, Projects Scored List, with the following recommendations: [1] Sewer North, expansion of sewer to the Salem area, should be included on the CIP, and [2] Sewer Line to Coneross I-85 & GCCP project should be clarified by enumerating the phases of the project.

Executive Session:

Ms. Cammick made a motion, seconded by Mr. Thrift, approved 4-1 [Mr. Dexter opposed] to enter Executive Session as allowed for in §30-4-70 (a) of the Code of Laws of South Carolina, as amended, 1976 for the purpose of:

- [1] discussion regarding pending litigation related to Oconee County v Hanger III, et. al.,
- [2] discussion of a contractual matter related to the Oconee Joint Regional Sewer Authority, and
- [3] discussion of a contractual matter related to Historic Oconee Courthouse LLC.

Council entered Executive Session at 6:52 p.m.

Council returned from Executive Session at 7:28 p.m. on a motion by Mr. Cain, seconded by Mr. Thrift, approved 5-0.

Mr. McCall stated that no action was taken in Executive Session.
