

MINUTES OCONEE COUNTY COUNCIL MEETING Regular Meeting February 2, 2016

Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root and Elizabeth G. Hulse, Clerk to Council present.

Call to Order

Mr. Cain called the meeting to order at 6:00 p.m.

Prior to Public Comment, Mr. Cain stated that the Recognition of Emergency Services Personnel would be deferred to the February 16, 2016 meeting.

Public Comment Session

Mr. Ryan Honea addressed Council in opposition to passage of Ordinance 2015-35; noting his opposition to the county paying the defendants attorney fees in the amount of \$35,000.

Senate Bill 672: Medical Marijuana Legalization / Mr. Charles Lutz

Mr. Lutz addressed Council voicing his opposition to passage of SC Senate Bill #672 which would legalize marijuana for specific medical uses. He requested that Council consider passage of a Resolution to formally oppose passage of Senate Bill #672.

Council took no action on this matter at this meeting.

Mr. McCall made a motion, seconded by Ms. Cammick to approve **Ordinance 2015-35** on second reading.

Mr. Dexter read from a prepared statement [copy filed with these minutes] voicing his concerns with and opposition to passage of **Ordinance 2015-35** and the included lease and release. Mr. Thrift, Ms. Cammick and Mr. Dexter had a lengthy discussion with various opinions offered regarding this matter.

Ms. Cammick made a motion, seconded by Mr. McCall, approved 4 – 1 [Mr. Dexter opposed] to amend **Ordinance 2015-35** as discussed in Executive Session.

Mr. Cain called for the vote. **Ordinance 2015-35** was approved 3 – 2 [Mr. Thrift & Mr. Dexter opposed] on second reading as amended.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5 - 0 to appoint Mr. Shawn Johnson to the open At Large Seat with their term being co-terminus with District I and III.
