Mr. McCall made a motion, seconded by Ms. Cammick, to approve **Resolution R2016-06** on first & final reading.

Mr. McCall made a motion, seconded by Ms. Cammick, approved 4 – 0 to [1] award of RFP 15-09 for Professional Engineering Consultant On Call Services to the following firms as outlined on the agenda item summary for the listed categories: Alta Planning & Design, Greenville, SC [Category A]; Davis & Floyd, Greenwood, SC [Category B]; Terracon, Taylors, SC [Categories C and D]; Thomas & Hutton, Greenville, SC [Category E]; H & M Surveying, Greenville, SC [Category F]; McMillan Pazdan Smith, Greenville, SC [Category G]; and [2] authorize the County Administrator to execute the original contracts after approval and renew these contracts yearly, up to five years total, as long as all work is deemed satisfactory.

E-One HP78 Aerial "Demo" Truck / Fire Services / \$675,000

Mr. McCall made a motion, seconded by Ms. Cammick, approved 4 – 0 to approve the purchase of a used E-One HP78 Aerial Truck from FireLine, Inc., of Winder, GA, for \$675,000.

Waterline Relocation for Cities of Seneca and Walhalla Department / \$380,092

Mr. Thrift made a motion, seconded by Mr. McCall, approved 4 - 0 to [1] make payment to Seneca Light & Water, a division of the City of Seneca, in the amount of \$219,832.00; and [2] make payment to the City of Walhalla in the amount of \$160,260.00 for engineering and construction costs for the relocation of waterlines.

Budget, Finance & Administration / Mr. Cain

Mr. Cain read from a prepared statement [copy filed with these minutes] highlighting the activities and discussions at the March 22, 2016 committee meeting.

Mr. Cain made a motion, seconded by Ms. Cammick, approved 3 – 1 [Mr. McCall opposed] to affirm the Committee's direction to have the Administrator to prepare the budget as provided and to include a 2.1 mill tax increase required to balance the budget.

Ms. Cammick made a motion, seconded by Mr. Thrift, approved 4-0 enter into Executive Session as allowed for in §30-4-70 (a) of the Code of Laws of South Carolina, as amended, 1976 for the purpose of:

- [1] discussing two Economic Development maters: Project Wales & Project Hawk;
- [2] discussion of a potential contractual matter related to a land purchase on Hwy 123;
- [3] discussion of a personnel matter related to the Master-in-Equity position;
- [4] to receive legal advice regarding a potential litigation matter; and
- [5] to receive legal advice regarding a contractual matter and matters related thereto.

Ms. Cammick made a motion, seconded by Mr. McCall, approved 3-1 [Mr. Thrift opposed] to direct the Administrator to proceed as discussed in Executive Session to investigate the potential breach of contract matter.

Adjourn Mr. McCall made a motion, approved unanimously 4 – 0, to adjourn at 8:29 p.m.
