Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root and Elizabeth G. Hulse, Clerk to Council present.

Mr. B. J. Littleton addressed Council voicing concerns regarding an Oconee County Sheriff's office deputy's conduct and allegations made against him that he believes to be untrue.

Ms. Ann Dreyer addressed Council [utilizing photograph handouts – copies of the photos filed with these minutes] regarding dilapidated property in the Port Bass subdivision.

Ms. Jean Jennings addressed Council regarding various topics to include her opposition to hiring an outside firm to assist with reassessment; DHEC's education regarding the West Nile virus; her support for the Dollar General project; and, her opposition to plutonium in South Carolina.

Mr. Jerry Barnett addressed Council in opposition to citizens in the agriculture community asking Council for handouts to purchase property for an Agriculture Center.

Ms. Susie Cornelius addressed Council in opposition to sewer expansion to exits 1, 2 and 4 on Highway 85.

Ms. Cammick made a motion, seconded by Mr. McCall, approved 5 – 0 to table third and final reading of **Ordinance 2016-17**.

Ordinance 2016-19 "AN ORDINANCE CANCELLING, REVOKING, AND RESCINDING OCONEE COUNTY ORDINANCE 2013-22; AND OTHER MATTERS RELATED THERETO" [Rescinding Patillo Land Swap Ordinance]

Mr. McCall made a motion, seconded by Ms. Cammick, approved 5 – 0 to approve Ordinance 2013-19 on third and final reading.

Mr. Dexter made a motion, seconded by Mr. McCall, approved 5-0 to approve \$152,000 from State & Local ATAX accounts noting exact amounts from each account will be determined upon receipt of the  $4^{th}$  Quarter State ATAX check.

#### **PRT Commission Local ATAX grant requests**

Mr. Cain asked Mr. Phil Shirley, PRT Director, to please in future provide return on investment information when available for ATAX grant requests for Council approval. Mr. Shirley stated he would do so for all future requests.

Ms. Cammick made a motion, seconded by Mr. Dexter, approved 5 – 0 to approve the ATAX grant request as presented on attached spreadsheet.

#### **Planning Commission / District IV**

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5 – 0 to appoint Mr. Nick Gambrell to the District IV seat on the Planning Commission with their seat being coterminus with Districts II, IV & V.

#### **Destination Oconee / District III**

Mr. Cain made a motion, seconded by Ms. Cammick, approved 5 – 0 to appoint Mr. Al Shadwick to the District III seat on the Destination Oconee Advisory Committee.

#### **Budget, Finance & Administration Committee**

Mr. Cain read from a prepared statement [copy filed with these minutes] highlighting the activities and discussions at the May 24, 2016 committee meeting.

#### **Third Reading for the Following Ordinances**

Ordinance 2016-01 "AN ORDINANCE TO ESTABLISH THE BUDGET FOR OCONEE COUNTY AND TO PROVIDE FOR THE LEVY OF TAXES FOR ORDINARY COUNTY PURPOSES, FOR THE TRI-COUNTY TECHNICAL COLLEGE SPECIAL REVENUE FUND, FOR THE EMERGENCY SERVICES PROTECTION SPECIAL REVENUE FUND, FOR THE ROAD MAINTENANCE SPECIAL REVENUE FUND, FOR THE VICTIM SERVICES SPECIAL REVENUE FUNDS, FOR THE BRIDGE AND CULVERT CAPITAL PROJECT FUND, GENERAL CAPITAL PROJECT FUND, AND FOR THE ECONOMIC DEVELOPMENT CAPITAL PROJECT FUND, ALL IN OCONEE COUNTY FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017"

Mr. Thrift made a motion, seconded by Mr. Dexter, to bring **Ordinance 2016-01** to the floor for discussion.

Ms. Cammick made a motion, seconded by Mr. McCall, to adopt budget document version #3 for **Ordinance 2016-01.** Mr. Moulder noted that version #3 is currently in the ordinance as approved at second reading. Ms. Cammick withdrew her motion and Mr. McCall withdrew his second.

Lengthy discussion followed with various opinions offered.

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 3-2 [Mr. McCall and Ms. Cammick opposed] to amend **Ordinance 2016-01** to include budget version #4 for consideration at the public hearing and for third and final reading.

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5-0 to table action on **Ordinance 2016-01** for third reading to the next regularly scheduled Council meeting scheduled for Tuesday, June 21, 2016.

Mr. Cain requested that staff advertise an additional public hearing be scheduled for the June 21, 2016 regular council meeting.

#### **Executive Session:**

Mr. McCall made a motion, seconded by Mr. Thrift, approved 5-0 enter into Executive Session as allowed for in §30-4-70 (a) of the Code of Laws of South Carolina, as amended, 1976 for the purpose of:

- [1] discussion regarding a potential property purchase related to the Rock Quarry,
- [2] receiving legal advice regarding a contractual matters and issues related thereto.

Council entered Executive Session at 7:41 p.m.

Council returned from Executive Session at 9:04~p.m. on a motion by Mr. Thrift, seconded by Ms. Cammick, approved 5-0.

Mr. Cain stated that no action was taken in Executive Session.

Mr. Thrift made a motion, seconded by Mr. Dexter, approved 5 – 0 to direct the Administrator to proceed with investigation of the property purchase related to the Rock Quarry as discussed in Executive Session.

Ms. Cammick made a motion, seconded by Mr. McCall, approved 3-2 [Mr. Thrift & Dexter opposed] to direct the Administrator to proceed as discussed in Executive Session regarding the contractual matter.
