

MINUTES OCONEE COUNTY COUNCIL MEETING Regular Meeting September 6, 2016

Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root and Elizabeth G. Hulse, Clerk to Council present.

Call to Order

Mr. Cain called the meeting to order at 6:00 p.m.

Public Comment Session

Ms. Elizabeth McCary addressed Council regarding **Ordinance 2016-08** requesting her mother's parcel be removed from the request.

Mr. Dean Smith addressed Council regarding **Ordinance 2016-08** noting his property is surrounded and he does not wish to be included in the zoning for the area.

Mr. McCall made a motion, seconded by Mr. Cain, approved 3 – 2 [Mr. Thrift & Mr. Dexter opposed] to postpone third reading of **Ordinance 2016-22** to allow time to review the Auditor's presentation.

Millage Proposal for Tax Year 2016 [continued]

Mr. Moulder noted that the Auditor requires Council action to formally adopt the millage and that action regarding Ms. Hubbard's presentation is required at this meeting for her to complete her work.

Mr. Cain made a motion, seconded by Ms. Thrift, approved 5 - 0 to hold Oconee County millage the same as adopted in 2015.

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5 – 0 to hold the School District of Oconee County millage the same as adopted in 2015.

Mr. Cain made a motion, seconded by Mr. Dexter, approved 5 – 0 to approve the Keowee Fire Special Tax District millage at 14.5 mills.

Discussion of Potential Uses for the Oakway Intermediate School, and Regarding Council Accepting the School from the School District of Oconee

Council member discussed various options, uses and commitments from civic groups for this building to include but not limited to:

- Identification of Entity to Oversee Operations
- Sheriff Office Satellite Office
- Clemson Extension
- Fair Play and Oakway Recreation
- Oakway Fire Department for Meetings
- Heritage Quilt Trail Group

Ms. Cammick made a motion, seconded by Mr. McCall, approved 5 – 0 to accept the Oakway Intermediate School from the School District of Oconee County with the proviso that a 90 day due diligence period be established prior to acceptance.

Local ATAX Grants / Fall 2016 Cycle / \$47,410

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve the ATAX grant recommendations in the amount of \$47,410, per the attached spreadsheet.

ITB 16-06 / Gateway Signage / Grant Funded

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5 – 0 to approve the award of ITB 16-06 to J.F. Contractors, LLC, of Sumter, SC, in the amount of \$76,601.

Two Ford Police Interceptor SUV's / Sheriff's Office / \$55,216

Mr. Dexter made a motion, seconded by Mr. McCall, approved 5 – 0 to approve purchase of two (2) Ford Police Interceptor SUV's to Vic Bailey Ford of Spartanburg, SC, in the amount of \$55,264.00, per State Contract # 4400011559.

<u>Old Business:</u>

Attorney General Opinion Regarding Airport Hanger Lease, Disputed Taxes & Litigation

Mr. Dexter made a motion, seconded by Mr. Thrift, approved 5 – 0 to incorporate the Attorney General Opinion [dated September 1, 2016; copy filed with these minutes] in to the backup for this meeting as part of the permanent record.

New Business:

None discussed at this meeting.

Board & Commission Appointments

Agriculture Advisory Board

Mr. McCall mad a motion, seconded by Mr. Thrift, approved 5 – 0 to appoint Mr. Douglas Hollifield to the District II seat on the Agriculture Advisory Board.

Mr. Thrift nominated Ms. Kim Alexander for an At Large Seat.

Mr. Cain nominated Mr. Rex Blanton for an At Large Seat.

Mr. Dexter nominated Mr. Frank Ables for an At Large Seat.

Mr. Root noted that the nominations should be voted on in order received with both a hand and voice vote to facilitate the Clerk tallying the votes accurately; noting that a Council member cannot vote for more than two nominees.

Ms. Alexander received four votes.

Mr. Blanton received four votes.

Mr. Ables received two votes.

Ms. Kim Alexander [co-terminus with Districts II & III] and Mr. Rex Blanton [co-terminus with Districts II, IV & V] are appointed to the two At Large Seats on the Agriculture Advisory Board.

Council returned from Executive Session at 8:48 p.m. on a motion by Mr. Thrift, seconded by Mr. Dexter, approved 5 – 0.

Mr. Cain stated that no action was taken in Executive Session.

Mr. McCall made a motion, seconded by Ms. Cammick, approved 5 - 0 to direct the Administrator to proceed as discussed in Executive Session regarding a potential property purchase related to the Rock Quarry.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5 - 0 to direct the Administrator to proceed as discussed in Executive Session regarding legal advice regarding a contractual dispute.

Motion to Reconsider

Mr. Moulder noted that the action previously made during the meeting regarding setting millage was not specific enough for the Auditor to set the millage; therefore, she requested that Council reconsider their action at this time.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 5 – 0 to reconsider the establishment of millage for Oconee County and the School District of Oconee County.

Ms. Hubbard provided Council with a proposed "Approved Millage Rates for Fiscal Year 2016-2017: Exhibit A" [copy filed with these minutes] for their review and discussion.

Discussion followed.

Mr. Thrift made a motion, seconded by Ms. Cammick, approved 4 - 1 [Mr. Dexter opposed] to approve the millage on "Approved Millage Rates for Fiscal Year 2016-2017: Exhibit A" as presented at this meeting.

Mr. Thrift made a motion, approved unanimously 5 – 0, to adjourn at 9:01 p.m.
