

MINUTES OCONEE COUNTY COUNCIL MEETING Regular Meeting April 18, 2017

Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root and Katie D. Smith, Clerk to Council present.

Mr. Hart made a motion, seconded by Mr. Davis to approve **Ordinance 2016-41**.

Lengthy discussion followed to include:

- Should be able to return to control free zone if you volunteer to join
- Time limit to return to control free
- Farming is a way of life
- Preserve the farm
- On a volunteer basis to be zoned
- Ordinance sent to Planning Commission, sent to Council, back to Planning Commission, back to Council, three presenters today [2 in favor, 1 opposed]

Mr. Davis called for the vote. The motion **failed** 2-3 [Ms. Cammick, Mr. Hart, & Mr. McCall opposed].

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0 to approve **Ordinance 2017-07** on third & final reading.

Ordinance 2016-37 "AN ORDINANCE GRANTING CERTAIN EASEMENT RIGHTS TO BLUE RIDGE ELECTRIC COOPERATIVE NEAR THE OCONEE REGIONAL AIRPORT FOR THE PURPOSE OF RELOCATING EXISTING ABOVE-GROUND ELECTRICAL LINES TO UNDERGROUND LINES; AND OTHER MATTERS RELATED THERETO."

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0 to approve **Ordinance 2016-37** on third & final reading.

Mr. Root noted Blue Ridge submitted revisions to the following paragraphs on all easements:

- Paragraph one: property descriptions to include the neighbors;
- Paragraph three: easement premises;
- Paragraph 7: specific purpose.

Mr. Cain made a motion, seconded by Mr. Davis, to approve **Ordinance 2017-05** on first reading. Discussion followed to include:

- Similar projects along route 123
- Revenue for the county
- Problems could arise to include noise pollution, increased law enforcement, fire protection, and litter that could potentially cost the county money
- Investments developers provide

Ms. Cammick called for the vote. The motion passed 5 - 0 to approve **Ordinance 2017-05** on first reading.

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0 to approve **Ordinance 2017-08** on first reading.

Resolution R2017-02 "A RESOLUTION AUTHORIZING, UNDER CERTAIN CONDITIONS, THE EXECUTION AND DELIVERY BY OCONEE COUNTY, SOUTH CAROLINA OF A FEE IN LIEU OF TAXES AGREEMENT WITH PROJECT ENTRY WITH RESPECT TO A PROJECT IN THE COUNTY WHEREBY THE PROJECT WOULD BE SUBJECT TO PAYMENT OF CERTAIN FEES IN LIEU OF TAXES, AND WOULD BE PROVIDED CERTAIN SPECIAL SOURCE CREDITS AGAINST FEE PAYMENTS, AND WOULD BE PLACED INTO A JOINT COUNTY INDUSTRIAL AND BUSINESS PARK; AND RELATED MATTERS."

Resolution R2017-04 "A RESOLUTION AUTHORIZING, UNDER CERTAIN CONDITIONS, THE EXECUTION AND DELIVERY BY OCONEE COUNTY, SOUTH CAROLINA OF A FEE IN LIEU OF TAXES AGREEMENT WITH PROJECT RAVEN WITH RESPECT TO A PROJECT IN THE COUNTY WHEREBY THE PROJECT WOULD BE SUBJECT TO PAYMENT OF CERTAIN FEES IN LIEU OF TAX; AND RELATED MATTERS."

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0 to approve **Resolution R2017-04** on first & final reading.

Discussion Regarding Action Items

Response to Planning Commission's request for direction in relation to corridor planning

The Planning Commission sent Council a letter asking for direction regarding corridor planning. Discussion followed to include:

- Traffic issues on the 123 corridor from Clemson coming into Oconee County are very concerning.
- Tackling one corridor at a time because each one is unique.
- Speak with the engineering department at Clemson that specializes in traffic and ask to make a senior project to design.
- Billboard regulations
- Corridors, i.e. Hwy 123, Hwy 11, Hwy 130, Hwy 28, Hwy 59, etc.
- Billboard and sign restrictions
- Architectural standards
- Parking lots
- Pedestrian Friendly areas
- Lighting

Additional discussion followed.

Ms. Cammick is to draft letter to send to the Planning Commission.

Gravel donation request for Oconee County Baptist Camp Meeting

The County Council gravel donation account has a negative balance at this time. No further funds for this fiscal year are available. Due to the tight budget for next year, there will not be a gravel donation account.

The request for gravel donation for Oconee County Baptist Camp Meeting has been denied.

Request "Amnesty Week" for Oconee County Public Library

Due to the high volume of penalties and fees, Council agrees to give the OCPL amnesty week so that patrons can return books they borrowed without having to pay the fees for the late return.

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0, to approve Amnesty Week for Oconee County Public Library.

Board & Commission Appointments

Board of Zoning Appeals

Mr. McCall made a nomination, approved 5 - 0, to appoint Ms. Gwen Fowler as the District II representative on the Board of Zoning Appeals.

Building Codes Appeal Board

No nominations were made.

Old / Unfinished Business:

In the absence of Mr. Moulder and Mr. Root, Council wants someone appointed in case of any problems that may arise. Council requested Mr. Rick Martin to be considered.

Mr. Davis reminded everyone of The Great Oconee Cleanup that is scheduled for Saturday, April 22, 2017 at 8:00 a.m. He noted there has been a lot of great support and noted the signs out are for safety measures. Additionally, he noted he appreciates all that have signed up and all in the County that is helping out. Finally, he thanked Sheriff Mike Crenshaw and the inmate labor and also the inmates for their hard work.

Mr. Richard Blackwell, Economic Development Director, addressed Council regarding The Great Oconee Cleanup. He noted this is a start of an ongoing battle with the litter problem in our community. This will be starting on April 22, 2017 and thanked Sheriff Crenshaw for the idea.

At this time, 124 volunteers have registered and had received a call from a fraternity on Clemson campus that will bring about 40 additional volunteers.
