

## MINUTES OCONEE COUNTY COUNCIL MEETING Regular Meeting June 20, 2017

Mr. Root noted at the last public hearing the School District of Oconee County [SCOD] presented a slight decrease in their numbers. The prior on a second reading school operations were noted at \$66,463,508

which was decreased to \$65,797,536, which would reduce the total school district to \$82,895,916.

Mr. Davis made a motion, seconded by Mr. Cain approved 5 - 0, to amend **Ordinance 2017-02** to reflect the corrected amount as stated by Mr. Root, County Attorney.

# **Building Codes Appeal Board**

Mr. Davis made a nomination, approved 5 - 0, to appoint Mr. Kevin Knight as the District IV representative on the Building Codes Appeal Board.

## **Old / Unfinished Business:**

Ms. Cammick noted there have been several budget meetings and also the strategic planning meeting, however, Mr. Moulder was not given the Administrator's Goal list for the fiscal year 2017-2018 [copy filed with these minutes].

Mr. McCall made a motion, seconded by Mr. Hart, to approve the Administrator's Goal list as the opportunities present to follow through with the goals.

Mr. Cain wanted to additional items to the list:

- Incentive municipalities to increase recycling
- Utilize inmate labor
- Scan plats and maps onto Internet
- Revamping the County website
- Instituting a true capital investment/vehicle plan
- Building security at Pine Street
- Connect the Palmetto Trail to the Green Crescent Trail

Mr. Moulder noted a temporary employee has been diligently working for about a month and a half with scanning records in Register of Deeds. All of the records should be scanned in by the summer. He further noted he would like to move her to Probate Court so that the records could be scanned as well.

On Mr. McCall's previous motion, he also added an amendment to the agenda to add the task list as provided, including Mr. Cain's additions that was approved unanimously.

Ms. Cammick noted the email [copy filed with these minutes] from Brian Ramey, Mayor of Westminster, was eye-opening. He notes in the email that out of 852 participants in Westminster's recreation program, 589 are outside of the city limits and they are funding \$196,037 and requested that Council consider increasing funding for recreation to help offset some of those costs.

Mr. Davis thanked the City of Westminster and Mayor Brian Ramey for presenting the document about these issues. He noted that this is not just in Westminster but also in Seneca, Walhalla, and Salem as well. He further noted he has received numerous phone calls regarding the Recreation Task Force and citizens are very appreciative of the funding.

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0 to enter into Executive Session for the following purposes, as allowed for in § 30-4-70(a) of the South Carolina Code of Laws:

[1] to receive legal advice regarding potential resolution of claim brought in the South Carolina Administrative Law Court against the Oconee County Assessor regarding an alleged overpayment of property taxes.

[2] to receive legal advice regarding a contract with RCI Services to provide plan review and inspection services on an as needed basis.[3] the discussion of a personnel matter in reference to the reduction in force issues.

Council returned from Executive Session at 7:43 p.m. on a motion made by Mr. Davis, seconded by Mr. Cain, approved 5 - 0.

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0, to direct the County Attorney to work to resolve the claim as discussed regarding legal advice on the potential resolution of the claim for the overpayment to the Assessor.

Mr. Davis made a motion, seconded by Mr. Hart, approved 5 - 0, to direct the County Administrator to investigate departmental reconfiguration as discussed.
