Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, County Administrator Scott Moulder, County Attorney David Root, and Katie D. Smith, Clerk to Council present.

**Call to Order**

Mr. Root called the meeting to order at 6:00 p.m. Mr. Root presided over the meeting pending the election of a new chairperson.

**Public Comment Session**

Mr. Albert Shuler addressed Council utilizing a handout [copy filed with these minutes] regarding death and suicide investigations.

**Moment of Silence**

Mr. Root asked for a moment of silence prior the Invocation by the County Chaplain.

**Invocation by County Council Chaplain:**

Mr. Root, County Council Chaplain, gave the invocation.

**Pledge of Allegiance:**

Mr. Tom Markovich led the Pledge of Allegiance to the Flag of the United States of America.

**Approval of Minutes:**

Ms. Cammick made a motion, seconded by Mr. Davis, approved 5 – 0 to approve the December 19, 2017 meeting minutes as presented.

## **Presentation to Council / Luther Lyle / Oconee Town Acquisition**

Mr. Luther Lyle, Director and Curator of Museum of the Cherokee in South Carolina, addressed Council utilizing a handout [copy filed with these minutes and copy of “Oconee Town Acquisition Celebration” on DVD and also on Oconee County YouTube channel “Your Oconee”].

Discussion continued to include but not limited to:

- 4,000 visited the museum in 2016
- Part time employee on Thursday, Friday, & Saturday and visitation has quadrupled since her arrival
- Will also open other days of the week
- More visitors from Cherokee Nation

Mr. Davis thanked Mr. Lyle for what he does and noted how big of an impact it has had on our area.

Mr. McCall nominated Ms. Cammick as Council Chairperson. Mr. Cain nominated Mr. Davis as Chairperson. Mr. Root called for the vote. Ms. Cammick was elected Council Chairperson on a 3 – 2 [Mr. Davis & Mr. Cain opposed] vote.

The meeting was then turned over to Ms. Cammick to preside as chair.

### **Council Vice Chairperson**

Mr. Cain nominated Mr. Davis, approved 5 – 0, as Council Vice Chairperson.

### **Council Chairperson Pro Tem**

Mr. Davis nominated Mr. Cain as Council Chairperson Pro Tem. Mr. McCall nominated Mr. Hart as Council Chairperson Pro Tem. Ms. Cammick called for the vote. The vote **failed** 2 – 3 [Ms. Cammick, Mr. Hart, & Mr. McCall opposed] for Mr. Cain as Council Chairperson Pro Tem. Mr. Hart was elected Council Chairman Pro Tem on a 3 -2 [Mr. Davis & Mr. Cain opposed] vote.

## **Appointment/Re-Appointment of the following Appointed Officials**

### **Clerk to Council**

Ms. Cammick made a motion, seconded by Mr. Davis, approved 5 – 0, to reappoint Ms. Katie D. Smith as Clerk to County Council.

### **County Chaplain**

Ms. Cammick made a motion, seconded by Mr. Cain, approved 5 – 0, to re-appoint Mr. Root as the County Chaplain.

## **Appointment of Council Committees for 2018 by Chairman**

Mr. Cammick made a nomination, approved unanimously, to approve the following County Council Committee appointments as made by Ms. Cammick.

Mr. Hart as Chairperson; Mr. Davis and Ms. Cammick as committee members.
