

## MINUTES OCONEE COUNTY COUNCIL SPECIAL MEETING October 8, 2018 9:30 a.m.

Oconee County Council met at 9:30 A.M. in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members [except Mr. McCall], County Attorney David Root, and Katie. D. Smith, Clerk to Council, present.

## Call to Order:

Ms. Cammick called the meeting to order at 9:33 a.m.

## **Executive Session:**

Mr. Davis made a motion, seconded by Mr. Hart, approved 4 - 0, to enter into Executive Session for the following purposes, as allowed for in § 30-4-70(a) of the South Carolina Code of Laws:

[1] To discuss employment matter, and receive legal advice as necessary, related to hiring of County Administrator, including candidate interviews.

Council entered Executive Session at 9:33 a.m.

Council returned from Executive Session at 1:57 p.m. on a motion made by Mr. Davis, seconded by Mr. Hart, approved 4 - 0.

Ms. Cammick stated that no action was taken in Executive Session.

Mr. Davis made a motion, seconded by Mr. Hart, approved 4 - 0, to call back candidates #2, #3, & #4 for follow up interviews.

Both groups are to submit questions before the interviews, and the questions are to be vetted by the Council members for the first group and then to the County Attorney for review. And, the second group's questions are to be vetted by the County Attorney alone. Subsequent to the interviews, each person involved is to anonymously submit rankings of the candidates and comments to the Clerk to Council for submission to Council.
