**Budget:** \$161,969.42 **Project Cost:** \$66,542.00 **Balance:** \$95,427.42 This purchase is for a 2020 Chevrolet Silverado 4500 Medium Duty, 4-wheel drive, Crew Cab Work Truck with Knapheide 9' utility body, that will be used by the New Construction Crew to haul equipment to and from jobsite. This truck will be replacing a 2008 Ford F250 (102.22) which will be sold as surplus via public auction or GovDeals.

It is the staff's recommendation that Council approve the purchase of a 2020 Chevrolet Silverado 4500 Medium Duty Truck with Knapheide 9' utility body, to National Auto Fleet Group of Watsonville, CA in the amount of 66,542.95, per Sourcewell – National Auto Fleet Group Contract Number 120716-NAF. To ratify and authorize the County Administrator's (and designated staff's) application for and receipt of CARES Act Grant No. 3-45-0016-028-2020 (the "Grant") for the Oconee County Regional Airport

- The Grant is provided in accordance with the CARES Act to provide funding to help offset a decline in revenues arising from diminished airport operations and activities as a result of the COVID-19 Public Health Emergency.
- The maximum obligation of the United States payable under the Grant is \$69,000.
- No County or State match or contribution is required.
- Expenditures of Grant funds are limited to capital, maintenance or operating costs of the Airport.

It is staff's recommendation that Council ratify and authorize application for and administration of the Grant.

Mr. Elliott made a motion, seconded by Mr. Hart, approved 5 - 0, to ratify and authorize the application for and administration of the CARES Act Grant No. 3-45-0016-028-2020 (the "Grant") for the Oconee County Regional Airport.

- (1) Approve grant submission for the Bureau of Justice Assistance FY 2020 "Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program" (the "Grant"), seeking up to \$600,000 in Grant funding; and, (2) authorize the County Administrator and her designated staff to apply for, administer, and take all other actions necessary to execute the Grant on behalf of the County.
- Grant submission deadline is May 21, 2020.
- Grant funding will be allocated toward a collaborative effort between the Oconee County Sheriff's Office and Oconee Addiction Recovery & Solutions (OARS) to develop a locally driven response to opioids, stimulants and other substances, including treatment and recovery services, diversion programs, and education and prevention activities.
- Funds will be used to help develop comprehensive law enforcement, community health and evidencebased programs to improve responses to at risk for overdose offenders and provide alternative-toincarceration services to those suffering from substance abuse disorders.
- The OARS Center opened in March 2020 following a three-year collaborative effort with Oconee County and has been approved to house twenty (20) in-patient clients. The OARS Center also has a formal education lab for non-residential recovery programs.

It is staff's recommendation that Council approve the FY 2020 Comprehensive Opioid, Stimulant, and Substance Abuse Site-based Program (COSSAP) grant application submission to develop a locally driven response to opioids, stimulants and other substances in Oconee County.
