Mr. Elliott called the meeting to order at 6:00 p.m.

Mr. Durham made a motion, seconded by Mr. Hart, to amend **Ordinance 2021-01** to include the current year's fiscal budget plus the cost of living increase for County employees and the addition of the public safety positions. The motion **failed** 2-3 [Mr. Davis, Mr. Cain, & Mr. Elliott opposed].

Mr. Elliott called for the vote on **Ordinance 2021-01** as originally submitted for first reading. The motion passed, 3-2 [Mr. Hart & Mr. Durham opposed.]

- Development of affordable housing
