Call to Order

Mr. Elliott called the meeting to order at 6:00 p.m.

Mr. Elliott opened the meeting reminding the public they have two opportunities to speak during Council meetings, which is during the public comment session and also during the public hearing session, if scheduled. Other than those two instances, the public should remain silent during the Council meeting. Anyone making a disturbance during the meeting will be asked to leave Council Chambers for the remainder of the meeting.

Pastor Carleathea Benson addressed Council with her concerns related to maintenance of County roads and culverts, affordable housing, and her opinion that a newsletter would be helpful in keeping citizens informed of happenings within the County, then closed with her thanks to Council for their service.

Ms. Monica White, member of the Oconee County Library Board of Directors, offered her appreciation to Mr. Daniel Polk for his 26 years of service as Head Librarian at the Salem Branch of the Oconee County Public Libraries.

Council Members Comments

Mr. Davis addressed Pastor Benson's concerns related to maintenance of County roads and culverts and affordable housing, then went on to state that communication is important for our citizens and referenced our YouTube channel, Your Oconee, where all meetings are live streamed and available for viewing afterwards as well.

Mr. Cain added that there is a competitive, low income housing project in the City of Seneca and in regards to her pipe pressure, he noted Oconee County government does not operate any utilities and suggested she contact her local utility provider.

- 3. New Code Enforcement Officer position
- 4. New PRT Administration position
- 5. New Park Ranger position

Ms. Brock assisted Mr. Haney with understanding the proposed budget in relation to airport jet fuel.

Mr. Haney ended by stating his opinion that the proposed FY2022-2023 budget is leaps and bounds better than past years.

Mr. Wayne Owens addressed Council in support of **Ordinance 2022-01** and offered his personal opinion that the increase in the budget is due to growth in the County.

Mr. Cain made a motion, seconded by Mr. Davis, to approve **Ordinance 2022-01**.

Mr. Elliott stated our proposed budget increase reflects growth in our tax base before reassessment. We will decrease the millage to negate the increased revenue due to the reassessment. Public safety is nearly fifty percent of our budget. We are budgeting 13 new positions and 12 are public safety positions. We are increasing the Sheriff's and deputy's salaries, along with an increase in recreation funding.

Mr. Davis noted that Mr. Durham was not present on second reading of **Ordinance 2022-01** and went on to state that the amount of budget meetings this year was the most that he has ever attended in his time on Council.

Mr. Davis went on to defend proposed funding for the requested 13 new positions and the increase in funding for recreation and Oconee Support included in **Ordinance 2022-01**.

Mr. Cain spoke in support of the requested 13 new positions, with special focus on the additional Code Enforcement Officer that has been requested.

Ordinance 2022-01 approved 3 – 1 [Mr. Hart opposed], on third and final reading.
