Council Members Comments

Mr. Hart addressed the recent Facebook posting of a document restricting the number of chickens citizens could own, noting this was "bogus" and not an official Oconee County document.

Mr. Elliott stated he was not behind the posting of the above reference document.

Mr. Davis stated the document in question is included in the backup material from a previous Council meeting and was provided by a citizen, noting the he would like any citizen provided material that is added to backup to be labeled or stamped as "Not Official" and that the County should be more protective over the unauthorized usage of the County seal.

Mr. Mize agreed with Mr. Davis regarding stamping or labeling of citizen provide materials as "Not Official".

Mr. Elliott inquired if the County had a trademark on the County seal.

Mr. Root, County Attorney noted that the County does have a common-law protection on the County seal and the Destination Oconee logo and added that cease and desist letters have been sent out in the past.

Ms. Brock informed Council that a stamp has been ordered that will state "CITIZEN PROVIDED MATERIAL NOT OFFICIAL OCONEE COUNTY DOCUMENT" and noted that any citizen material provided to Council, that is added to the backup, will have this stamp.

As requested by Mr. Davis, Mr. Durham noted that he requested the assistance of County Attorney, David Root, when composing **Ordinance 2024-10** and this ordinance is intended to help maintain the growth of the budget, to keep it in line with County growth and inflation.

Mr. Elliott inquired if the percentage change in the population of the County from the previous year and the Consumer Price Index numbers, both determined by the South Carolina Revenue and Fiscal Affairs Office, would be available to formulate the General Fund growth limitation before the third reading of the 2024/2025 budget.

Mr. Durham noted that these numbers would be available before third reading of the budget.

Mr. Davis offered lengthy comments in opposition to **Ordinance 2024-10** and noted that it is his belief that this ordinance will cause confusion among citizens regarding the budget.

Mr. Elliott made a motion to amend **Ordinance 2024-10**, under the title "1. General Fund growth limitation", to include in parenthesis "Limitation for the budget year 2024-2025 is _____%" and for this percentage to be filled in before or at public hearing and third reading of the 2024/2025 budget.

Mr. Elliott noted to Mr. Durham that it is he belief that Ms. Brock, and the public, need to know the 2024/2025 budget limitation.

Discussion Regarding Action Items

Title: 2025 Kenworth T-880 with Roll-Off Cable Hoist Amount: \$275,633.00

Procurement was approved by Council in Fiscal Year 2023-2024 budget process.

Budget: \$275,633.00 Project Cost: \$275,633.00 Balance: \$0.00

(Funding from Capital Equipment / (325) Vehicle Fund)

This Roll-Off truck is a 2025 Kenworth T-880 cab and chassis with a Galfab hoist. The hoist system consists of the rail system and cables used to pick-up waste containers and a tarp system to cover any open containers. The truck will be used to service roll-off containers at the County's 11 recycling centers, parks, and other departments as needed, as well as, recycling activities at industries and commercial facilities that participate in the commercial recycling program. The 2025 Kenworth Roll-Off truck meets the specifications required by the Solid Waste department.

Due to having multiple aging trucks and instability of parts availability, this will be an addition to the Solid Waste roll-off truck fleet until several newer trucks can be acquired to ensure there is no disruption of service for the recycle centers. The Vehicle Maintenance Director approves this purchase.

Pricing for the Kenworth Truck is from the Sourcewell national purchasing co-operative, contract number 060920-KTC for Kenworth Trucks. The contract discount is from 9.6% up to 44.6% off MSRP. For this purchase, the discount amount for Cab and Chassis is 34.5% off MSRP and for added items 0% markup. The Sourcewell contract allows government agencies to purchase directly from an authorized dealer. Sourcewell contracts are bid and awarded on a national level and purchases may be fulfilled by authorized local or state dealers. Worldwide Equipment Enterprises, Inc. of Columbia, SC is an Authorized Dealer for Kenworth.

This contract allows the Authorized Dealer to include added equipment or options at a cost of no more than 5% of the cost of the Cab and Chassis. Worldwide Equipment has opted not to charge the 5% markup allowed to include the Hoist and Tarp System. Worldwide Equipment Enterprises, Inc. will coordinate the installation of the Hoist and Tarp System; therefore, the County will issue one Purchase Order to Worldwide Equipment Enterprises, Inc.

It is the staff's recommendation that Council approve the purchase of a 2025 Kenworth T-880 with Hoist and Tarp System to Worldwide Equipment Enterprises, Inc. of Columbia, SC in the amount of \$275,633.00, per Sourcewell Contract Number 060920-KTC.

(Funding from Capital Equipment / (325) Vehicle Fund)

This purchase is for a new 2024 or 2025 55-Ton Lowboy Trailer that will be used by the Roads and Bridges to transport heavy equipment throughout the county to job sites and to transport equipment and materials for other county departments when requested. Lead-time after receipt of order is 10 to 12 months; therefore, the year model will be a 2024 or 2025 depending on the build completion date.

After researching Lowboy Trailers that would meet the requirements of the department, staff determined that the Globe 55LB639549 Lowboy Trailer would best meet the needs of the Roads and Bridges Department.

This Lowboy Trailer will be replacing a 1999 Evans Trailer (201.15); which will be sold as surplus or replace older equipment used in other County departments. The Vehicle Maintenance Director approves this purchase.

Sourcewell has awarded Globe Trailer Mfg., Inc. contract # 092922-GLB for Globe Trailers. The contract discount is from 2% up to 15% off MSRP. For this purchase, the discount amount for Trailer is 15% and for added items 2%. This contract allows government agencies to purchase directly from the Manufacturer. Sourcewell Contracts are bid and awarded on a national level. Hills Machinery of Greenville, SC is an Authorized Dealer for Globe Trailer Mfg., Inc. Hills Machinery of Greenville, SC will service the equipment for any warranty work required.

It is the staff's recommendation that Council approve the purchase of a Globe 55-Ton Lowboy Trailer from Globe Trailer Mfg., Inc. of Bradenton, FL, in the amount of \$96,633.10, per Sourcewell Contract # 092922-GLB.

Procurement was approved by Council in Fiscal Year 2023-2024 budget process. Budget: \$123,845.00 Project Cost: \$123,845.00 Balance: \$0.00 (Funding from General Obligation Bond)

At the June 1, 2022 meeting, Council approved the award of RFP 20-02 for On Call Engineering Services to Thomas & Hutton of Greenville, SC for Category E: On Call General Engineering Services. Administration wishes to contract with Thomas & Hutton to provide engineering services for the master sanitary sewer pump station, force main and limited gravity sewer at Exit 4. Thomas and Hutton will provide services that include General Consulting, Field Investigation Phase, Design Phase, Permit Phase, Construction Administration and monitoring during the Construction Phase and Closeout Phase.

The proposed pump station is expected to be located in the southwestern corner of the Project Tiger site, and the associated proposed force main will extend approximately 3,000 LF to the north through the site and then approximately 4,750 LF west along Highway 243 and a portion of gravity sewer along Doctors Road and W. Pine Grove Road in order to connect to a gravity main extension currently being designed and installed by others for OJRSA.
