As requested by Mr. Hart, Mr. Root provided an explanation regarding why item number six was added back to **Ordinance 2024-18**, as approved by Council at the May 7, 2024 meeting.

Mr. Elliott clarified that with the addition of item number six to **Ordinance 2024-18**, it allows for a notice of public hearing before voting at second reading.

Motion approved 5 - 0.

Mr. Elliott made a motion to amend the motion to change the special election back to the original proposed date of July 30, 2024.

This motion did not receive a second, therefore it failed.

As requested by Mr. Root, Mr. Durham made a motion, seconded by Mr. Hart, approved 4 - 1 [Mr. Elliott opposed], to amend **Resolution 2024-12** to read **Resolution 2024-13**, correcting a scrivener's error.

Mr. Durham provided an explanation as to why he believes postponing this special election to coincide with the general election in November, noting it would give the citizens in this proposed special tax district more time to think about how they would like to vote.

Mr. Elliott commented that he hopes the 800 people who voted to have a special election to become a special tax district will remember this in the primary.

Mr. Root clarified that this would still be a special election but it would just be held on the same day as the general election in November.

Mr. Mize inquired as to how many citizens reside in the proposed special fire tax district.

Mr. Kevin Christenberry, Corinth Shiloh Fire Department Chief, stated the approximated number was around 7,000, noting state law requires 15% of voter signatures are needed to hold a special election to become a special tax district, adding that not all the citizens in this proposed area are registered to vote.

Mr. Christenberry continued to provide comments to Council as to why he believes that the special election needs to be held on the original proposed date of July 30, 2024 and not held during the November general election.

Mr. Durham inquired as to how much money was raised for the operation of the Corinth Shiloh Fire Department last year.

Mr. Christenberry stated that approximately \$90,000.00 was raised last year and provided an explanation to Council as to how they raise and expend their funds.

Mr. Mize added that he wants to see this special fire tax district happen for this area but also that he agrees with Mr. Davis' comments regarding the possible significant tax increases the citizens in this area could see.

Mr. Christenberry went on to note that they have had about 20-30 citizens at the three community meetings they have held to discuss this topic.

Mr. Durham noted he is not worried about the supporters of this proposed special fire tax district, he is more worried about those who may have to choose between paying their taxes and buying medication that month, further stating he want to represent these types of citizens by giving them ample time to consider this proposal.

Mr. Danny Delmarco, a volunteer for the Corinth Shiloh Fire Department, joined Mr. Christenberry at the podium and provided Council with his arguments against postponing this special election until November.

Mr. Delmarco went on to add that the funding for the municipal fire departments in the County is considerably more than the funding the Corinth Shiloh Fire Department receives.

Mr. Tim Murphy, a volunteer for the Corinth Shiloh Fire Department, then joined the other gentleman at the podium and passionately addressed Council, urging them to support holding this special election in July and not November.

Mr. Christenberry provided Council with an explanation as to how they acquired a sprinkler system for the Corinth Shiloh Fire Department, noting the department applied for and received a grant for the funding.

Mr. Delnmarco explained to Council how the fire department uses the money they raise and how they use the funds allotted from the County.

Ms. Elizabeth Crockett then joined the three gentlemen at the podium and proceeded to add her comments as to why she believes this proposed special fire tax district is a benefit to her area and urged Council to again, hold this special election in July and not November.

Mr. Durham stated that the is still in favor of passing **Resolution 2024-13** and asked that discussions be held at the next Law Enforcement, Public Safety, Health and Welfare Committee meeting regarding the Corinth Shiloh Fire Department.

Mr. Davis then presented questions regarding the Corinth Shiloh Fire Department annual budget and went on to add comments related to fire safety within the County, asking for a future meeting of Council dedicated to discussing the future of fire safety and funding options.

Mr. Durham agreed with Mr. Davis, noting a meeting dedicated to this topic is a good idea.

PRT Commission State and Local ATAX Recommendations for FY 2025

Amount: \$1,077,196

These requests were unanimously approved by the PRT Commission on 05/2/24.

PRT Commission and PRT staff recommends \$589,959 from Local ATAX for the FY25 Local ATAX Supplemental budget (attached) for routine expenditures eligible to offset general fund expenditures. Grant cycles and project specific funds will continue to be recommended at the quarterly meetings.

PRT Commission and PRT staff recommends \$332,237 from the 65% State ATAX Fund and an estimated \$155,000 from the 30% ATAX Fund for a total of \$487,237 for the FY25 Visit Oconee SC Budget. The 65% Funds are utilized for salaries to operate the Visit Oconee office and are reimbursed to the County quarterly to offset the general fund. The 30% Funds, by state law, are specifically for tourism advertising and promotion, distributed quarterly and are market dependent.

Local ATAX balance including encumbrances as of 5.1.24 = \$573,325.23

Local ATAX FY25 Revenue projection is \$1,040,000.00 65% State ATAX balance as of 5.1.24 = \$479,661.00 65% State ATAX FY24 Revenue projection = \$350,000.00

> \$55,000.00 of the Procurement was included in the 2023-2024 Budget process. \$130,776.80 of Procurement has been requested in the FY 24-25 budget process.

This request is for the purchase of Gravix block for the Rock Quarry. These materials are needed to construct the headwall for the new Vertical Hopper that was approved at the March 19, 2024 County Council Meeting. The headwall will be 30' high and must be able to carry extreme loads due to the loaded haul trucks that will back to the edge of the wall to dump material into the vertical hopper. In normal applications, a headwall would either consist of a concrete structure that would be poured in place or by using retaining wall blocks that tie back into the earth using geofabric. This type of application would ultimately cost more and does not allow for moving the wall in the future. The Gravix block removes the need for the geofabric and will allow for the wall to be dismantled and reinstalled at a future location within the Rock Quarry. The Gravix system includes all necessary engineering and technical support, and will allow Quarry staff to construct and install the headwall without the use of outside contractors providing a significant cost savings for the county. Earth Wall Products is the sole proprietor of the Gravix wall system and the materials / product can only be purchase through their company.

This proposal includes PE Stamped Design including wall drawings for construction, Internal Stability Design of the walls and Precast concrete conforming to DOT specifications.

Rock Quarry staff has reviewed other prefabricated wall systems and have found the Earth Wall Products Gravis retaining wall system best meets their need.

This purchase is a Sole Source purchase.

Staff is requesting a 10% contingency to cover any unforeseen items that may arise. The number of blocks is estimated and could be more or less once construction has been completed.
