#### **Attorney's Comments**

Mr. Root provided an update related to Project Spark **Ordinance 2024-15**, noting the minimum job requirement was previously listed as 150 but has been amended to reflect 130.

#### Administrator's Comments

Ms. Brock stated to Council that she was giving up her time to allow Ms. Stacey Whichel with Evergreen Solutions, LLC, who completed the Comp and Wadge Study for Oconee County, to provide an update of their findings to Council.

Ms. Stacey Whichel, Project Manager, addressed Council utilizing a power point presentation entitled, "Classification & Compensation Study Oconee County, SC" [copy in backup] and provided an overview of their findings, proposed plans and recommendations.

Ms. Brock noted that the anticipated amount of \$2 million dollars was budgeted for implementation of the Comp and Wadge study and this would include Fire and Emergency Services, even thought they were left out of a portion of the study.

Mr. Davis voiced his concern that this presentation was not listed on the posted agenda.

Ms. Brock addressed Mr. Davis' concern by noting it was an error and miscommunication on her part that this presentation was not listed on the agenda.

Emergency Replacement of Electric Fire Pump System Department: Facilities Maintenance Amount: \$66,105.63 <u>10% Contingency: \$6,610.56</u> Total: \$72,716.19

Budget: \$72,716.19 Project Cost: \$72,716.19 Balance: \$0.00

The current fire suppression system at the Oconee County Courthouse is currently failing and is out of service. The original fire suppression system was installed when the Courthouse was completed in 2003. The fire suppression system includes an electric fire pump that boosts water pressure and pumps the water to all five (5) floors of the Courthouse. Without the electric fire pump, the water pressure coming into the building would not be sufficient to reach the upper floors if the sprinkler system was needed.

Impact Fire Services is the maintenance provider of the sprinkler and fire suppression system at the Courthouse. During routine maintenance, it was discovered that the current fire pump system had components that had failed and was out of service.

Emergency. On June 12, 2024, purchase order 56084 was issued and the order was placed. The expected time for completion is 2 weeks.

Due to safety risk of the Courthouse building the citizens inside, the Facilities Maintenance Director request to proceed with Impact Fire Services as an emergency procurement. Impact Fire Services has extensive knowledge of the current fire suppression system. If staff were to issue a solicitation for the replacement of the electric fire pump system, it would delay the purchase by approximately two to three months. This additional time could prevent the sprinkler system from activating in the event of fire in the Courthouse.

## It is the staff's recommendation that Council authorize the Administrator to transfer sufficient funds to appropriate line item.

# Request Council's approval for submission of an Airport Safety and Maintenance Grant application to the South Carolina Aeronautics Commission (SCAC) and commit \$35,370.00 in local funding to replace the rotating beacon and tower.

#### Total cost of this project: \$141,480.00

South Carolina Aeronautics Commission's portion will be 75 % of total cost equating to \$106,110.00 Oconee County providing the remaining 25% of total costs, equating to \$35,370.00

- Oconee Airport has received numerous complaints due to the lack of visibility and identification of the Airport during night-time operations.
- The existing Beacon/Tower has been in service for an overextended amount of years resulting in rust, corrosion, and safety issues.
- The South Carolina Aviation Commission, (SCAC) reviewed the height, condition, and age of the existing beacon/tower and determined a replacement was warranted.

The South Carolina Aviation Commission has agreed this project is Grant eligible. Approval of application is contingent upon SCAC approval and funding.

## It is the staff's recommendation that Council authorize the County Administrator to execute documents related to the submission and possible award of the SCAC Airport Safety and Maintenance Grant and to commit \$35,370.00 in local funding.
