Discussion Regarding Action Items

Request for Council's approval for to commit matching funds, not to exceed \$10,000, and the submission of Oconee County Park Recreation and Tourism's application for the South Carolina Parks and Recreation Development (PARD) Fund grant for Seneca Creek County Park Shade Structures.

Amount: Not to exceed \$10,000.00

- The South Carolina Parks and Recreation Development (PARD) Fund is a state-funded, noncompetitive, reimbursable grant program for eligible local governments which provide recreational opportunities within each county.
- PARD is an 80-20 match grant program.
- If approved, the PARD funds will be used to add three (3) cantilever shade structures to three (3) new picnic sites at the newly constructed Seneca Creek Park. The picnic sites are fully exposed to the sun and are extremely hot during the summer season.
- Renovation at the Seneca Creek Boat Ramp were completed in 2023 with the establishment of a three-lane boat ramp, courtesy docks, a floating fishing pier, kayak launch and restrooms.
- The amount of funds requested for the PARD application is \$25,000.

Oconee County requests the commitment of the matching funds for the PARD grant from the Oconee County Parks, Recreation and Tourism Capital Projects Fund.

It is staff's recommendation that Council support the Oconee County PARD grant application and commit matching funds, up to \$10,000.00, for the Seneca Creek County Park shade structures.

Mr. Elliott made a motion, seconded by Mr. Hart, to approve the support of the Oconee County PARD grant application and commit matching funds, up to \$10,000.00, for the Seneca Creek County Park shade structures.

Mr. Mize inquired if the requested shade structures were similar to patio umbrellas.

Project is part of the PRT Expansion Plan and Funding is from PRT Accommodations Tax (ATAX). Budget: \$103,283.90 Project Cost: \$103,283.90 Balance: \$0.00 (Funding from Local ATAX Fund)

This Destination Oconee Signage Project involves the manufacture and placement of gateway entry signage at multiple unique spots along state highways to provide a sense of place when coming into Oconee County. The existing gateway signs are approximately 20 years old and in need of replacement and updating. PRT staff included new gateway signs for two (2) additional locations.

Bid quantities for this solicitation were estimated and allows the actual purchase quantities to be increased or reduced depending on available funding. The Airport had requested the "Welcome to Oconee" sign, located near the runway, to be replaced during this project. The cost for materials and installation for this sign is \$6,663.20.

ITB 23-17 was issued on May 21, 2024 for multiple Gateway Signs. This bid was advertised and fifteen (15) companies were notified of the bid opportunity. On June 20, 2024, formal sealed bids were opened for this project. Seven (7) companies submitted bids with Knight Sign Industries, Inc., of Tuscaloosa, AL, submitting the lowest responsive and responsible bid, in the amount of \$87,837.00. Staff is requesting a 10% contingency, in the amount of \$8,783.70, to cover any unforeseen items that may arise.

It is the staff's recommendation that Council:

- 1. Approve the award of bid ITB 23-17 to Knight Sign Industries, Inc., of Tuscaloosa, AL, in the amount of \$87,837.00.
- 2. Approve a 10% contingency in the amount of \$8,783.70.
- 3. Approve the addition of the Oconee County Regional Airport "Welcome to Oconee" Sign, in the amount of \$6,663.20.

Procurement was approved by Council in FY 2024-2025 budget process, in the PRT Capital Millage. Budget: \$154,074.35 Project Cost: \$154,074.35 Balance: \$0.00

(Funding from PRT Capital Project Millage Fund)

The Overhead to Underground Conversion of Duke Energy Utilities at South Cove County Park is the first step in the expansion plan of the recreational facilities and parking. Duke Energy will Remove: Five power poles with attached equipment (guy wires, insulators, hardware, etc.), two single phase overhead transformers, one three phase overhead transformer, 800 ft of three phase overhead wire (four total runs at 800 ft a piece). Duke Energy will be Installing: Two new poles necessary to go underground with wire and attached equipment, 600 ft of three phase underground primary, 2000 ft of single phase underground primary looped back to pole from existing, splices into existing underground primary loop that services campground, 600 ft of boring, two underground transformers, one three phase transformer, reconnection of existing services currently fed from overhead.

This project is a sole source due to Duke Energy being the power supplier for South Cove Park. Duke Energy does not allow third party companies, unless directed by Duke Energy, to conduct burial or work on their power lines.

The recreational and parking expansion plan was approved by Duke and the Federal Energy Regulatory Commission (FERC) in June 2024. The plan includes two new lighted tennis courts, expansion to 12 pickleball courts and a new lake overflow parking area. All project items are currently being engineered for bid and will be brought to Council for consideration prior to the project starting. The Overhead to Underground power must be completed before projects for the recreational and parking expansion can begin.

Staff is requesting a 10% contingency to cover any unforeseen items that may arise.

It is the staff's recommendation that Council:

- 1. Approve the Overhead to Underground Power Conversion to Duke Energy, in the amount of \$140,067.59.
- 2. Approve a 10% contingency in the amount of \$14,006.76.

Mr. Durham recused himself from voting [recusal form filed in backup] on the above requested overhead to underground utility conversion at South Cove County Park and turned the meeting over to Mr. Mize.

Mr. Elliott made a motion, seconded by Mr. Hart, to approve the Overhead to Underground Power Conversion to Duke Energy, in the amount of \$140,067.59 and to approve a 10% contingency in the amount of \$14,006.76.

Council's meetings shall be conducted pursuant to the South Carolina Freedom of Information Act, Council's Rules and the Model Rules of Parliamentary Procedure for South Carolina Counties, latest edition. This agenda may not be inclusive of all issues which Council may bring up for discussion at this meeting. Items are listed on Council's agenda to give public notice of the subjects and issues to be discussed, acted upon, received as information and/or disposed of during the meeting. Items listed on Council's agenda may be taken up, tabled, postponed, reconsidered, removed or otherwise disposed of as provided for under Council's Rules, and Model Rules of Parliamentary Procedure for South Carolina Counties, latest edition, if not specified under Council's rules.
