Council returned from Executive Session at 3:48 p.m. on a motion made by Mr. Hart, seconded by Mr. James, approved 5-0.

As requested by Mr. Durham, Mr. Hart made a motion, seconded by Mr. James, approved 5 - 0, to approve the termination of County Administrator, Ms. Amanda Brock, per the terms of her contract and to authorize the Chairman to issue a written statement of the reasons alleged for the proposed removal pursuant to SC Code 4-9-620 and the Administrator has a right to a public hearing pursuant to the SC Code 4-9-620. The Administrators contract, while terminated without cause, is terminated due to Council's loss of trust in her.

Mr. Durham read aloud a statement on behalf of Council that provided details related to the circumstances surrounding Council's loss of trust in the County Administrator, noting that Mr. Phil Shirley, current PRT director, has agreed to serve and interim County Administrator while the search begins for a permanent replacement.
