**ORDINANCE 2025-26** AN ORDINANCE TO AMEND SECTION 28-9 ("USED AND WASTE TIRES") OF CHAPTER 28 ("SOLID WASTE MANAGEMENT") OF THE OCONEE COUNTY CODE OF ORDINANCES TO ALIGN THE SAME WITH THE 2025 AMENDMENTS TO S.C. **ORDINANCE 2025-27** AN ORDINANCE TO REVISE AND EXPAND THE LOCAL CONTRACTOR / VENDOR PREFERENCE PROVISIONS CONTAINED IN THE OCONEE COUNTY PROCUREMENT CODE.

Mr. Elliott made a motion, seconded by Mr. Hart to approve **Ordinance 2025-27** on second reading.

As requested by Mr. Root, Mr. James made a motion to amend **Ordinance 2025-27**, seconded by Mr. Elliott, to change section 5:2, which is a threshold to when local preferences apply, from \$10,000.00 to \$25,000.00 so that it aligns with the advertising and formal bid requirements within the procurement code.

Mr. Root offered Mr. Hart clarification related to the above proposed amendment.

Mr. Root pointed out to Mr. Hart the proposed changes to the Oconee County Procurement Code as requested.
