- 1. Call to Order Mr. Blanton called the meeting to order at 6:30 PM.
- 2. Approval of minutes from 7/13/2020 Ms. Callahan made a motion to approve the minutes, seconded by Mr. Hollifield and approved 4/0.
- 3. Approval of minutes from 10/12/2020 Ms. Callahan made a motion to approve the minutes, seconded by Ms. Sewell and approved 4/0.

- 4. Citizen comment Written comments submitted by four citizens were read by Mr. Blanton. All spoke to the need for a USDA Certified animal processing plant in Oconee County, or at minimum a SCDA Certified plant. This need was exacerbated by COVID-19 as farmers are facing extreme process scheduling delays. Comments also highlighted the economic value to adding a certified processing plant to the county.
- 5. Animal Processing There was a discussion on how AAB could help mitigate the absence of a certified animal processing plant. Mr. Hollifield made a motion that Ms. Callahan and Ms. Sewell craft and present a letter to the County Council wherein they will outline the need for a USDA OR SCDA Certified animal processing plant in Oconee County, what resources are required to meet the need (building size, utilities, machinery, etc.) and request that Council approach the State Legislature to temporarily relax restrictions on meat certifications to allow sale of meats to markets and other retail outlets. Motion was seconded by Ms. Sewell and approved 4/0.

Ms. Callahan made a motion that a sub-committee shall be formed to research solutions and inform and monitor the County Council and others on any proposed resolutions for issues regarding animal processing in Oconee County. Ms. Sewell seconded the motion and it was approved 4/0. Ms. Callahan and Ms. Sewell will serve as members of the sub-committee.

- Farmer's resource guide The updated document was reviewed. Several missing resources were noted. Staff will update the document and email to board members for final review. Document will then be aesthetically improved and posted on Oconee County website
- 7. Agriculture month proclamation Ms. Callahan made a motion to approve the Oconee County Council Proclamation supporting the South Carolina's Right to Farm Act as submitted. Mr. Hollifield seconded the motion and it was approved 4/0. Staff will aesthetically improve the document. Document will be presented to County Council by Ms. Callahan and Ms. Sewell when they address Council regarding animal processing.
- Adjourn Discussion regarding the Comprehensive Plan with regards to agriculture will be on next month's agenda. Mr. Hollifield made a motion to adjourn meeting, seconded by Mr. Blanton and approved unanimously at 7:35 PM.
