 - i. Ms. Alexander asked Mr. Coley if there is a way to obtain a list of all active farms in Oconee County
 - ii. Ms. Alexander asked for a budget that can cover printing and mailing educational and resource materials
 - 1. Mr. Blanton Agriculture needs to be a line item on the proposed budget
 - iii. Ms Alexander Grassroots coalition in each district to host public meetings with farmers in order to communicate about current

issues in agriculture and coordinate around these issues
