- Call to order- Ms. Alexander called the November 13 meeting to order at 6:01pm

- 7. History of the Golden Corner Industrial Park and discussion about ramifications of Sewer South infrastructure
 - Jamie Gilbert is on our December agenda to discuss possible industry recruitments that will support Oconee County Agriculture.
- 8. Public discussion Session [3 minutes per person] If you are not able to attend in person and you have a comment, you may submit it by contacting the Planning Department at <u>planninginfo@oconeesc.com</u> or 864-638-4218, so that we may receive your comment and read it into the record.
 - Discussion ensued about the state of logging in the county, and the decline in industry since the mid-1990s. Concerns were expressed about the over-importation of goods that are driving the prices down of domestically produced materials.
 - Energy generators that burn pulp wood/pellets to produce electricity, thus supporting the timber industry and creating energy.
 - i. Ms. Alexander-made phone calls to Blue Ridge Electric about the

possibility, but was told that we are not de-regulated, therefore cannot start this industry.

- ii. According to the Canton Mill, a "Wood Basket" is a 200-mile radius.
- Ms. Alexander: Cargill could be a potentially good industry to recruit since Oconee County is number one in the state for poultry.
- The price of land in Oconee County has gotten too high to afford to farm.
- Sentiments were expressed that next to poultry, logging is one of the most disliked and misunderstood industries; folks are not educated in how it works. Discussion ensued about the importance of education for the public, so that they vote to support their interests. Trees are a renewable resource.
- The lack of a pulp mill is going to severely impact the timber industry.
- **9.** Adjourn: Mr. Whiten made a motion to adjourn at 7:19pm, seconded by Mr. Blanton and approved 5/0.

ON AGRICULTURE REPORT

Purpose and Need

Oconee County's mission includes protecting "communities, heritage, environment, and natural resources in an ever-changing world" —a goal that has become increasingly difficult to accomplish in the past three decades.

Farmland is being converted into non-farm uses at an alarming rate. According to recent census data, Oconee County's farmland has declined approximately 20% from 2002 to 2017.

The Report: Acknowledge agriculture is important to the economy and quality of life in Oconee County

- Recognize farmland is in decline
- Identify solutions to support farming and food producers

RECOMMENDATIONS

IMMEDIATE ACTIONS

- Revisit Comp Plan strategies
- Invest in farmland protection
- Increase farmland zoning options

Ag presented to the planning commission and discussed options. The board did not approve the Ag 2 zoning proposal.
