

The Budget, Finance & Administration Committee on Wednesday, April 29, 2009 at 6:00 PM in Council Chambers to review the proposed FY 2009-2010 Oconee County budget. All Council Members were present along with Elizabeth G. Hulse, Clerk to Council.

Call to Order:

Chairman Dexter called the meeting to order at 6:00 p.m.

Ms. Brown addressed the Committee regarding outstanding issues from previous workshop meetings to include:

- O Impound Lot / Sheriff's Department: Terry Wilson has identified a location at Vehicle Maintenance that would meet the needs. A fence could be installed there for the price of the security system in the budget request. The Sheriff's Department requests from the Committee approval to change the line item description from a security system to fencing. Mr. Thrift made a motion, seconded by Mr. Dexter, approved 3 0 to approved the line item
- Mr. Thrift made a motion, seconded by Mr. Dexter, approved 3-0 to approved the line item description change for the Sheriff's Department as outlined above.
 - o Coroner Fees: A handout was provided detailing these fees. No action was taken.
 - o **Animal Control**: Reviewed fuel rate for Fort Hill Natural Gas, surplus vehicle and follow-up request for consideration of a removable Tommy Lift for their trucks.
 - o 1% COLA from FY 08-09: These funds are still available and will be moved to fund balance as of July 1, 2009 to be designated for FY 09-10
 - O **Human Resources:** HR Contingency Account used \$14,500 out of budgeted \$200,000. This and the Council contingency account are the only two accounts that Council has the authority to move funds from one department to another department.

Mr. Dexter made a motion, seconded by Mr. Suarez, approved 4-0 to reduce line item 010-717-60707 by \$10,000 and move this amount to line item 010-707-30080.
