<u>Continued FY 2019-2020 Budget Discussion – Ms. Amanda Brock, Administrator & Ms. Ladale</u> Price, Director of Finance

Discussion continued to include:

- 1.3 mills designated to Economic Development fund and 2.0 mills designated to Capital Vehicle/Equipment Fund
- Employee increases, which includes benefits and fringe
- Reinstate employee evaluations
