Approval of Minutes

Discussion Items

FY2020-2021 School District of Oconee [SDOC] Budget Presentation

Ms. Gloria Moore addressed the Committee utilizing a PowerPoint entitled "School District of Oconee County FY2020-2021" [copy filed with backup materials] and gave a brief presentation.

Ms. Moore noted the School Board will have 1st reading of the proposed budget on May 11, 2020 and will have a public hearing and School Board will have 2nd reading on May 18, 2020. She further noted they will present to Council for discussion on May 19, 2020. Additionally, she noted SDOC will need additional revenue and will be coming back to Council.

Dr. Thorsland addressed the Committee highlighting the following:

- Minimal savings from electricity, etc.
- Moving forward next year with no salary increase for any employees and maintain this year's budget unless the Legislative tells SDOC otherwise
