# Call to Order:

Mr. Elliott called the meeting to order at 4:30 p.m.

# **Moment of Silence**

Mr. Elliott asked for a moment of silence prior to the Invocation by County Council Chaplain.

# **Invocation by County Chaplain**

Mr. Root, County Council Chaplain, gave the invocation.

# **Pledge of Allegiance**

Mr. Hart led the Pledge of Allegiance to the Flag of the United States of America.

# **Approval of Minutes**

Mr. Hart made a motion, seconded by Mr. Mize, approved 5 - 0, to approve the March 24, 2023 Budget Workshop minutes as presented.

### **Presentation**

Mr. Grant Davis with Mauldin & Jenkins, LLC, an independent auditing firm, addressed the Committee utilizing a document entitled, "Annual Comprehensive Financial Report For the Fiscal Year Ended June 30, 2022", which can be viewed by visiting <a href="https://oconeesc.com/finance-home/financial-transparency/statements-and-reports">https://oconeesc.com/finance-home/financial-transparency/statements-and-reports</a> and gave a brief presentation of findings to the Committee, noting there were no instances of non-compliance or internal control deficiencies found throughout the conduct of the audit.

### **Discussion Items**

FY2023-2024 Budget Discussion and Review

Ms. Brock addressed the Committee by first noting the FY2023-2024 Budget document has been updated to reflect changes within the budget.

Ms. Brock continued to provide an overview of the budget changes to the Committee, noting that \$723,036.00 has been cut from the previously presented budget.

Mr. Durham stated that he believes the budget should not grow faster than County growth and plus inflation, noting numbers from research he has been conducting on past County Budgets.

Mr. Durham went on to state that he believes the FY2023-2024 Budget should not exceed \$65, 231,000.00.

Mr. Elliott offered comments related to the inflation rate.

Mr. Davis noted that budgeting should not be to a number but to a need.

Mr. Durham made a motion, seconded by Mr. Hart, approved 3 - 2 [Mr. Elliott and Mr. Davis opposed], to direct staff revise the FY2023-2024 Budget not to exceed \$65,231,000.00.
