# Technical Services Division Background

Traditionally duties have been shared among various other OCES personnel and contracted to outside vendors.

Need was identified to expand in-house capabilities, increase efficiency of technology oversight, and enhance services available

December 2023: Full-Time Position Added shared duties of EM Planner and Technical Services

February 2024: Part-Time position added for additional Technical Services Support.

## March 2024

- Standardized programming deployed to all OCES Staff radios to address reported programmatic issues (approx. 60 subscriber units updated)
- Technical Services team visits Fire Chiefs' Association, Rescue Chiefs' Association, and multiple other department monthly meetings to introduce team and begin identifying areas to provide support.
- Engaged Radio Committee to continue work of identifying priorities for standardized template design for County-wide deployment.
- Began attending monthly coordination meetings with Prisma Health Ambulance, Prisma Dispatch, and OCSO Dispatch.

# April 2024

- Complete inventory & reallocation of all OCES Staff radio equipment
  - Allocation of station-assigned portable radios for Oconee Fire staffed roles.
  - Standardized programming template in place across all staff.
- Held initial coordination meeting with OCSO Technical Services/Dispatch team
- Technical Services team assigned responsibility for oversight of all OCES Vehicle Upfitting and aftermarket equipment oversight.
- Completed full inventory of all OCES vehicles with priority of identifying any issues with electrical, warning, and radio systems.
- Completed full inventory of Cradlepoint mobile internet routers, developed plan for location-based dispatch program implementation.

# May 2024

- Full Inventory of all EOC technology assets completed and tracking, replacement plans identified.
- Developed and began implementing plan for development of "Field Comm" program including upfitting of existing vehicle allocated to this program.
- Conducted site visits at all Oconee County Radio System tower sites to identify details of repeater and system equipment.
  - Confirmed functionality of all repeaters and voting equipment.
- Purchased and placed in-service a new Starlink Satellite system for resilient internet access when working in remote areas or during times of terrestrial service outages.
  - Faster service, unlimited access, more cost effective than former "V-SAT" service.
  - Antenna to be mounted on Field-Comm vehicle for rapid deployment.

## June 2024

- Began multi-phased process of implementing transition from primarily analog phone lines in EOC / OCES Offices to the Oconee County Voice over IP (VoIP) system for enhanced telecommunication capabilities and coordination.
- New P25 compatible multi-mode repeater equipment purchased for expansion of existing infrastructure to support additional system capacity.
  - Anticipated delivery Q3 2024.
- Conducted a full "spring cleaning" and reorganization of the EOC in preparation for upcoming Oconee Nuclear Station FSE.
- Engaged a vendor to conduct a feasibility study and present recommendations for future radio system enhancement options, completed a strategic planning meeting and radio site visits.

## July 2024

- Received (9) new Kenwood NX 5000 series portable radios for deployment to Station 21 staff and officers for testing.
  - Compatible with MSA G1 AirPak communication pairing.
- Participated in Dress Rehearsal of ONS FSE supporting communications and technology needs.
- VoIP Phone system transition completed
- Installation & deployment of station alerting system at Station 21

# Ongoing Projects in Progress

- County-wide radio updates beginning 8/2024
  - Anticipated completion 10/2024
- Assigned Operations Channel at time of Dispatch
  - Ongoing testing with Station 21 first-due area, excellent feedback to date.
  - Further expansion anticipated Q4 2024.
- Standardization of radio equipment approved for use on the Oconee County Public Safety Radio System (additional information to follow)

## Approved Equipment Standardization

## • Purpose:


- Standardization of programming deployment, equipment compatibility, and verification of equipment function/quality.
- Ensure consistent pricing and utilization of Contract pricing, vendor lead time monitoring, etc.

### Process:

- Multiple approved options for Portable and Mobile twoway radio equipment
- Individual departments may purchase equipment directly, programming must be completed by an approved Oconee County Public Safety Radio System programmer (either OCES Technical Services or approved programmer)
- Departments may request that OCES directly purchase equipment, complete programming and distribute to department for simplicity through authorization of OCES to deduct cost from department funds.

# Channel Assignment Transition

- ALL County Emergency vehicles must be equipped with a mobile radio capable of operating on the current DMR Tier II Multi-Site digital system before further progress can be made in transitioning to channel assignments upon dispatch.
- Currently many departments have legacy mobile radios that need to be upgraded immediately.
   Upgrading these radios to meet current standards are the responsibility of the individual department.
- All new vehicles allocated to departments will come equipped with radios meeting thencurrent standards.
