- I. **Call to Order – 5:45 pm**
Present: John Adams, Barbara Askew (FOL), Bill Caster, Phillip Cheney (OCPL), Danny Day, Jody Gaulin, Ellis Hughes, Vicky Miller
- I. **Approval of Minutes – November 14, 2011**
–John approved, Ellis seconded, all approved.
- II. **Public Comment**
- III. **Friends Report: Barbara Askew**
 - December -- \$724 book sale; \$84 for lobby sales
 - January – good crowd on this very rainy day; sold \$365 \$1,270.88 (without lobby)
 - Good publicity on “Read to Me” program
 - Up to 310 members now
 - Let’s Talk About It starts Feb. 27th. Good sign-up for this program.

- IV. **Committee Reports**
 - a. **Finance – John Adams**
 - The Library Corporation’s Hosted Solution: Recommendation is to move to this solution; OC IT supports decision. Year one: \$6900; year 2 \$4500. Need to upgrade server; also security function moves to TLC. John moves that we move to the TLC solution; Bill seconds; all approved. Danny commented that we should write press release to show that OCPL is offering better 24/7 support. John Adams will draft facts; Ellis will write up for dissemination to news. Timing to be determined, possibly 30-60 days.
 - Seneca Library expense line item: \$38,826 in budget. Will the Providence Study come out of this? Need to let Finance Department know so we can have these funds available. Philip will follow up with Finance. John, Danny, and Ellis will work on upcoming budget with Philip.
 - b. **Policy/Personnel – Vicky Miller/Jody Gaulin**
Jody, Vicky, Philip will be going through goals and objectives for director after today’s meeting.
 - c. **Building/Grounds – Lee Barrett/Danny Day**
Danny reports that the buildings and bookmobile are still in place! Small leak in Seneca from this past few days rain is under control.
 - d. **Community Relations – Ellis Hughes/Carol Baumgarner**
-Community Needs Assessment. John recommended that we make public aware we’re going to do this and how it’s going to be done. “Library doing due diligence using county funds.” Can we ask Providence what other libraries have done in the PR effort?
 - e. **Capital Projects – Ellis Hughes/John Adams**
 - Community Needs Assessment update. Jody and John reviewed some of the history of evaluation locations, two-stories, flat roof, expansion space issues. Discussion of whether Providence should “rank” sites. Should we open the door to other sites? (John asked.) These are things to consider until Providence talks to us.
 - Philip/Blair have photos of what the other counties have been doing as a way of showing how behind Oconee is to the others. The group discussed various issues with getting go-ahead with new library.
 - Westminster expansion?? Should we go ahead?
