- B. Update on grants for social worker and for transportation for healthcare: updated Board that grant from Center (Center for Rural and Primary Healthcare) extended to end of May 2024. Transportation to Healthcare grant from Center will expire in June 2023. So far about 80% of funds have been expended.
