VII. Director's Report: Director reported about new Adult Services Librarian, Brittany Castro; also report on accessible ramp in Seneca [currently still with procurement], and there was a question on time frame; no word on the results of the Evergreen wage and time use study. Also commended Quientell Walker on his presentations and projects in February. M. Alles White commended Kerry Leeper Brock for her work, and Director reported that the Center for Rural and Primary Healthcare is extending the grant for the social worker for two years to May 31, 2026.

- B. Changes or appointments for committee assignments Committee assignments were switched as follows: M. Alles White to Buildings and Grounds; C. Powell to Finance. Motion to accept changes made by Henderson, seconded by Addison. Approved. 6-0.

  - Discuss county budget and State Aid: brief discussion of Evergreen wage and time use study and its effect on county budget; also brief discussion of possible increase in State Aid to Public Libraries of \$0.25 per capita [\$19,651.75 increase for oconee County if it passes]
  - B. Request to change meeting room and Study Room policy to allow staff adequate time to close: staff requested wording to be added to Library Policy Section II. Services, Item "E," Meeting Room, line 9, to stipulate that meeting AND study rooms must be vacated 15 minutes before the location closes. Motion to accept by Weekes, seconded by Holcombe. Policy approved 6-0.
