LIMITED IN-PERSON ATTENDANCE PERMITTED

Due to the Novel Coronavirus pandemic and the ongoing state of emergency, in-person attendance at this Commission meeting by members of the general public will be limited. Attendance will be limited to twenty percent of the stated maximum occupancy, which equates to thirty-four (34) persons (including Council members, other elected officials, and staff). Call to Order – Mr. Chapman called the meeting to order at 5:00pm and explained the procedure for electing new officers.

1. Election of Officers – Chair, Vice Chair, Secretary – Mr. Chapman asked for nominations for the Chairman. Mr. Pearson nominated Mr. Smith. Mr. Smith accepted the nomination and was voted in 5/0. Mr. Smith took the gavel and proceeded to ask for nominations for Vice Chairman. Mr. Johnson nominated Mr. Pearson and was voted in 5/0. Mr. Smith then nominated Mr. Chapman or staff as Secretary and was voted in 5/0.
2. Approval of the Planning Commission 2021 meeting calendar – Mr. Vassey made a motion to accept the option 1 calendar, seconded by Mr. Johnson. Mr. Pearson asked if they can add a second meeting to July and August and cancel if not necessary. Mr. Smith amended the motion to accept the option 1

calendar with the additions of July 8, 2021 (Thursday) and August 2, 2021. Mr. Pearson seconded the motion and the calendar was then approved by a vote of 5/0.

3. Approval of minutes from 12/07/2020 – Mr. Pearson made a motion to accept the minutes, seconded by Mr. Vassey and were approved 5/0.
4. Adjourn – The meeting was adjourned by unanimous vote at 5:10 pm.
