

# Minutes oconee county rescue squad advisory commission

Regular Meeting Thursday, September 28, 2023

The Oconee County Rescue Squad Advisory Commission met at 6:00 PM in the conference room, 415 South Pine Street, Walhalla. Kelly McCormick, Tammy Wilbanks, Steven Zahn, Mike Carroll and Scott Krein were present.

Pursuant to the Freedom of Information Act, notice of the meeting, date, time, place of meeting and agenda were posted on the bulletin board at the County Administrative Offices, 415 South Pine Street, Walhalla, SC, and the County Council website [www.oconeesc.com]. In addition, it was made available [upon request] to the newspapers, radio stations, television stations and concerned citizens.

- 1. Call to order Chairman Kelly McCormick called the meeting to order at 1800 hours.
- **2. Approval of Minutes -** Commissioner Zahn made a motion to approve the minutes from August 24, 2023, seconded by Commissioner Sprogis and approved 4-0.
- **3. Public Comment** Lt. Scott Shear from Seneca Rescue Squad wanted to thank Oconee County for replacing one of the squad's vehicles (1-Echo). He expressed concerned that the vehicle did not have some items he considered necessary for safety, such as a cage or net separating the cab from the equipment area, a fire extinguisher, a flashlight and some type of vehicle identifier located on the roof. He suggested these items be on a punch list for new vehicles in the future.

- Welcomed Donna Rogers as the at large member appointed to RSAC by the rescue chiefs
- Asked whether or not NR21 (no response for 21 staff) should be added to ERS
- Asked about progress on installing numerical identification on docks for emergencies; Director Krein reported that some have been done and it is a work in progress
- Voiced concern about lift assist calls that turn out to be true medical calls
