The Transportation Committee was scheduled to meet at 4:30 p.m. in Council Chambers, Oconee Administrative Offices, 415 South Pine Street, Walhalla, SC with all members present, County Administrator Amanda F. Brock, County Attorney David Root, and Katie D. Smith, Clerk to Council present.

**Call to Order:**

Mr. Hart called the meeting to order at 4:31 p.m.

**Approval of Minutes:**

Mr. Cain made a motion, seconded by Mr. Davis, approved 3 – 0 to approve the October 1, 2019 minutes as presented.

**Discussion & Action Regarding the Following Items:**

Ms. Brock noted that she and Mr. Reid visited Willow Creek along with Ms. Amy Gantt and have spoken with a few of the residents and noted she can proceed with the presentation or allow the residents that are present to speak.

Mr. Hart opened the floor to allow residents to address the Committee.

**Public Comment Session**

Mr. David Perham addressed the Committee regarding LED lights at the entranceway, missing paperwork, and thanked staff for coming out and looking at the problem.

Mr. Patrick Higgins addressed the Committee regarding accepting Phase I as it was originally designed and built when it was under the previous administration and met those standards at the time.

Ms. Amy Gantt, owner of Tigerhart Construction, addressed the Committee utilizing a handout entitled “Project: Twin View Sub-Division” [copy filed in backup materials] and noted she has

visited the subdivision with Chief Charlie King, Ms. Brock, and Mr. Reid and have went over some of the issues. Discussion continued.

Mr. Higgins asked the Committee if the cul-de-sac have to be paved or could have it gravel around it?

Ms. Brock answered noting it would have to be a continuous surface whether it is paved or gravel.

Mr. Davis made a motion, seconded by Mr. Cain, approved 3 – 0, for approval of conditional acceptance to be submitted to full Council for consideration at the January 21, 2020 meeting to accept Twin View Drive conditionally and upon the happening of the following events [*items listed below*] and, provided those items are completed within one year of the date of conditional acceptance, County will formally accept the roads upon transfer of appropriate easements / rights-of-way and dedication.

- Repair distresses in the roadway (i.e. pothole, alligator cracking)
- Delineation of the intersection with Critter Rd utilizing roadway striping
- Rip Rap inlet/outlet protection put on crossline pipes showing erosion
- Stabilization with grassing of bare spots in the road right-of-way
- Additional right-of-way provided to Oconee County as necessary
- Signage placed to alert drivers of a blind hill condition at the crests near the intersection of Cozy Hill Ct and Comet View Ct, and a street light in the sag between the intersections noted above with a perpetual maintenance agreement for its operation and maintenance

**Adjourn:**

Mr. Davis made a motion to adjourn, approved unanimously at 5:08 p.m.
