## **Discussion & Action Regarding the Following Items**

#### McAlister Road, West Union - Mr. Joey Lemmons

Mr. Joey Lemmons, representing Peninsula Point South subdivision, addressed the Committee with the request that Oconee County take the last fourth of a mile of McAlister Road in West Union into County maintenance.

Mr. Lemmons spoke on behalf of several other subdivisions who utilize this portion of McAlister Road and provided aerial maps [copies in backup] to the Committee for reference.

Mr. Kyle Reid, Assistant Director of Public Works, provided information related to road construction, noting the County would need an "As Built Survey" of the non-county-maintained portion of McAlister Road to be able to assess what improvements or corrections would be needed in order to accept the road into County maintenance.

Lengthy discussion followed between the Committee, Mr. Reid and Mr. Lemmons related to McAlister Road.

Mr. Hart recommended to Mr. Lemmons that the subdivisions making this request obtain an "As Built Survey" and return to the Transportation Committee for consideration to send to full Council for approval.

# <u>Discussion regarding the acceptance of Rosedale Way (P-4313) into County maintenance – Mr. Kyle Reid / Assistant Director of Public Works</u>

Mr. Reid addressed the Committee utilizing a power point presentation entitled, "Transportation Committee Meeting" [copy in backup] related to the acceptance of Rosedale Way in Seneca into County maintenance.

Mr. Reid provided details related to the developers request that the County accept Rosedale Way into County maintenance, noting to Mr. Hart this road was built to County specs.

Mr. Hart made a motion, seconded by Mr. Mize, approved 2-0, to send the request of acceptance of Rosedale Way in Seneca into County maintenance to full Council for consideration of approval.
