The Oconee County Capital Sales Tax Commission [CPSTC] met at 3:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with City of Seneca Representative Mollie Smith and Clerk to Council Elizabeth G. Hulse present.

Press: Pursuant to the Freedom of Information Act, notice of the meeting, date, time, place of meeting and agenda were posted on the bulletin board at the County Administrative Offices, 415 South Pine Street, Walhalla, SC, and the County Council website [www.oconeese.com/council]. This meeting was conducted as prescribed in South Carolina state law; Chapter 10, Article 3, Capital Project Sales Tax Act, Section 4-10-320, Commission creation; composition, A (2) (d) as follows [full article filed with these minutes]:

(A) The governing body of any county is authorized to create a commission subject to the provisions of this section. The commission consists of six members, all of whom must be residents of the county, appointed as follows:

(2) The municipalities in the county must appoint three members, who must be residents of incorporated municipalities within the county, and who are selected according to the following mechanism:

*(d) When less than three members are selected to the commission in accordance with the prescribed appointive index method, **the remaining member or members must be selected in a joint meeting of the commission appointees of the municipalities in the county. The member or members must be chosen from among the residents of the municipalities in the county that before this time have not provided a representative for the commission.***

Call to Order:

Appointment of Members to the CPSTC

Based on the formula outlined in 4-10-320 A (2) (d), the City of Seneca was the only municipality entitled to appoint a single member Oconee County was notified of Ms. Smith's appointment via press release [copy filed with these minutes].
