This Addendum #1 includes answers to the following question(s) and/or clarification(s) from Oconee County. **A signed copy of this Addendum #1 must also be returned with your bid.**

Question: In regard to the quote for X-Ray, the RFP states the following: "The County currently has a ½ meter table with our current system that we would like to use with the new machine, if possible"

If the vendor's roller tables are not compatible with the proposed machine, how many roller tables would the County like to use with the new x-ray scanner? A single table (at either entry or exit) or two tables, one at exit and one at entry? Shall the proposed roller tables be of equal length, i.e. ½ meter?

Answer: Only one roller table will be needed.

Question: In regard to the request that the awarded contractor shall: "Relocate current x-ray unit and walk-through metal detector to another location to be stored (approximately 3 blocks)," can the relocation occur within a reasonable time frame (i.e. 3-5 business days), or must the relocation occur simultaneously to the install of the new scanner?

Answer: The current x-ray unit and walk-through metal detector shall be moved the same day.
