

MINUTES OCONEE COUNTY COUNCIL MEETING

The regular Oconee County Council Meeting was held April 21, 1981 with all members present.

The Invocation was given by Mr. Williams.

Dr. Earle made a motion, seconded by Mr. Brandt, approved 4 - 0 to approve the minutes of the April 13, 1981 meeting.

Mr. Thomas J. Urich came before Council to request a Palm Reader's License for his son. Mr. Brandt made a motion, seconded by Dr. Earle, approved 4 - 0 that this matter be taken into committee.

Mr. Crain stated the County has \$1,300,000 in Revenue Sharing. A portion of this can be used in 1980-81 Supplemental Appropriation and the remainder is to be used in the 1981-82 fiscal year.

Mr. Wynn then stated the first public hearing for Revenue Sharing was held March 25, 1981 and there were two requests made at that time. Mrs. Norma King requested \$19,400 for the Oconee Community Theater and Ms. Joyce Jackson of the School Department requested \$12,350 for the continued funding of a camp for E.H. children.

Mr. Williams gave the first reading of the 1980-81 Supplemental Appropriation Bill with one correction: Line item 12 54 22L be changed to line item 12 20 22L, Maintenance. Mr. Williams made a motion this bill be adopted upon first reading, seconded by Dr. Earle, approved 4 - 0.

Mr. Butts made a motion, seconded by Dr. Earle, approved 4 - 0 that Oconee County get a Lima Shovel from Kingstree, Williamsburg County at no cost to the county, but reimburse Kingstree \$4,500 for expenses incurred on the shovel and up to \$1,500 to move the shovel to Oconee County. This \$6,000 will come from Contingency Fund.

Mr. Crain then stated that the County will be selling ten head of cattle May 15, 1981 at the Eastonelle Public Auction which would bring an excess of \$3,000. In anticipation of this he asked Council to allow him to take \$3,000 from Contingency for fertilizer, seed, etc. Mr. Brandt made this into the form of a motion, seconded by Mr. Butts, approved 4 - 0.

Mr. Crain stated that he and Mr. Butts had been to look at a Case tractor and other equipment which the County could make an even trade in on our Leylan Tractor which is not satisfactory for the County's needs. Council had no objections to this trade being made.

Mr. Crain stated there would be another Public Revenue Sharing Meeting May 5, 1981 at 6:30 P.M. just prior to the County Council Meeting.
