MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held February 7, 1984 at 7:00 PM in Council Chambers with all members present.

Members of the press present: Mark Davis - Seneca Journal, Mary McKenna - Greenville News & Dick Mangrum - WSNW Radio.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Brandt.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the minutes of the January 17, 1984 meeting be adopted as printed.

First on the agenda was a public hearing to receive public comments and/or suggestions concerning the usage of \$736,381 Federal Revenue Sharing Funds.

Mrs. Louise Bell was the only person present with written and/or oral comments concerning these funds. She requested any amount Council could give to help toward the building of a Farmer's Market Pavilion in the City of Seneca to benefit all farmers in the county. The total cost of the pavilion is \$225,000, it will be an open structure with a meeting room, kitchen and platform.

Mr. Walter Purcell gave the attached orientation and update on the "First Responder Program". In his presentation he informed Council that we now have thirty (30) trained personnel in this program and on February 25, 1984 sixty (60) personnel will be engaged in a refresher course or taking the "First Responder Program" for the first time.

At the recommendation of Mr. Bob Gaillard, Planning Director, Dr. Earle made a motion, seconded by Mr. Butts, approved 4-1 (Mr. Brandt voting against) to apply for a grant in the amount of \$34,000 for sewer to the new Blue Ridge Electric Property. This is a 90% HUD grant, 10% county matching.

Mr. J. Harold Thomas addressed Council on the possibility of consolidating the tax collector's position with the Treasurer's Office. Council Members Brandt, Butts, Earle & Harper were in general agreement with Mr. Thomas.

Supervisor-Chairman Crain & Mr. Williams were opposed because in addition to being opposed to abolishing an elected position, they maintained it would not result in a saving.

Mr. Williams made a motion, seconded by Dr. Earle, approved 5 - 0 to adopt Ordinance 84-1, "1983-84 Supplemental Appropriation Ordinance" on first reading in title only.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that Oconee County grant Mr. Corky Moss an easement over county property adjacent to County Roadway TU 5 with the understanding that his attorney draw up the easement and it be approved by the county attorney.

Mr. Harper made a motion, seconded by Mr. Butts, approved 5 - 0 to award Sports Merchandisers the bid for diving equipment for Emergency Preparedness. They were low bid at \$7,215.73.

Mr. Harper made a motion, seconded by Mr. Williams, approved 4-0 (Mr. Brandt out of room) to accept the high bid of Mr. David Ellison for cattle sold by the county in the amount of 5,250.

Mr. Harper made a motion, seconded by Mr. Williams, approved 5 - 0 to adopt the attached Arts & Historical Contract.

Council agreed to accept the bid of Chastain Insurance Agency not to exceed \$28,000 to insure the vehicles presently owned by the county.

Mr. Williams made a motion, seconded by Dr. Earle, approved 5 - 0 the attached transfers (no new monies) be adopted.

At the request of J. P. Stevens Mr. Butts made a motion, seconded by Mr. Williams, approved 5-0 that Oconee County improve a roadway in the Utica area to alleviate a major traffic problem. The estimated cost to Oconee County will be \$20,000 plus labor.
