## MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held May 1, 1984 at 7:00 PM in Council Chambers with all members

Members of the press present: Dick Mangrum - WSNW Radio, Susan Walsh - Seneca Journal, Mary McKenna - Greenville News & Ashton Hester - Keowee Courier.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Dr. Earle.

Mr. Butts made a motion, seconded by Dr. Earle, that the minutes of the April 17, 1984 meeting be adopted. Mr. Williams pointed out that the minutes should read that the farm property that was leased is \$ .50 per acre per month. With this amendment the minutes were adopted 5 - 0.

First on the agenda was a public hearing concerning proposed use of \$316,148 in federal revenue sharing funds. There was no one present with either written or oral comments concerning these

However, Mr. Crain read the attached letter, (received in the mail) from Mr. Donald L. Drumm concerning using a portion of these funds to build and equip a fire station for the Foxwood Hills

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 to adopt Ordinance 84-3, "Industrial Revenue Bonds for Johnson Controls" in the amount of \$1,000,000 in title only.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 to adopt Resolution 84-5, "Resolution & Petition to the State Budget & Control Board" concerning industrial revenue bonds for Johnson Controls in the amount of \$1,000,000.

Mrs. Sallie Smith, Deputy Clerk of Court gave the attached presentation on system one computer indexing for the Clerk of Court's Office to Council. Mr. Brandt made a motion, seconded by Dr. Earle that the bid be awarded.

Mr. Brandt amended the motion to read that due to the special circumstances that the over \$5000 approval be waived in the awarding of the bid. Dr. Earle seconded the motion and it was adopted 5 - 0.

The motion to award the bid as amended was also adopted 5 - 0.
