MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, January 2, 1990 at 7:00 PM in Council Chambers with all Council Members and the County Attorney present.

Call to Order

The invocation was given by Dr. Earle.

Invocation

Mr. Dyar made a motion, seconded by Mr. Strickland that the minutes of the December 19, 1989 meeting be adopted as printed.

Minutes

Dr. Earle made a motion, seconded by Mr. Strickland, approved 5 - 0 that the next to the last paragraph reading referred to Personnel Committee be corrected to read appropriate committee.

The minutes as amended were then adopted 5 - 0.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that Ordinance 89-8, "An Ordinance to Amend Ordinance 89-4, An Ordinance Granting Franchise to Oconee County Cablevision, Inc. its Successors & Assigns, to Operate and Maintain a Community Antenna Television System in the County Setting Forth Conditions Accompanying the Grant of the Franchise: Providing for County Regulations and Use of the Community Antenna System: and Prescribing Penalties for Violation of the Franchise Provisions" be adopted on third and final reading.

Ord. 89-8

Mr. Strickland made a motion, seconded by Dr. Earle, approved 5 - 0 that Resolution 90-1, "A Resolution in Memory of Phillip S. Lear" be adopted on first and final reading.

Res. 90-1

Mr. Dyar made a motion, seconded by Dr. Earle, approved 5 - 0 that the bid for the timber on the property at the Rock Crusher be awarded to West Union Lumber. They were high bid at \$2,700. (See attached bid)

At the request of the Purchasing Director, Mr. Dyar made a motion, seconded by Dr. Earle, approved 5 - 0 that the \$1,300 that was left from the budgeted amount for roofing the stockade be used to section off a room at the stockade for the CCS employees and construct shelves, etc. as well as install electricity in the portion of the building that is used to house items that are to be sold at auction.
