Please pass to Marianne Dillard and John Murray.

As we discussed earlier, I think it is in the best interests of the County to procure "commodity" 9-1-1 systems on the open market. I have prepared the attached change order to authorize Synergem to act as the County's agent in making these purchases. The following conditions will apply:

1. This procedure applies only to components for which a market price can clearly be established. An example would be Stratus servers or Wright-Line furniture.
2. The final price to the County will not exceed the established market price.
3. Synergem will detail how that price was established.
4. No procurement will be initiated without the written consent of both Mr. Murray and Ms. Dillard.
5. Procurement fees charged by Synergem must be included within the market price and clearly identified and subject to prior approval.
6. Installation and integration fees charged by Synergem will be clearly identified and subject to prior approval.

I am preparing a briefing paper on the lease option to present to your Finance Director on June 9.

JOB CHANGE ORDER NO. 1
TO THE AGREEMENT DATED FEBRUARY 4, 2004
BETWEEN OCONEE COUNTY, SOUTH CAROLINA
AND SYNERGEM EMERGENCY SERVICES, LLC.

On February 4, 2004, Oconee County, South Carolina ("Client") and Synergem Emergency Services, LLC ("Synergem") entered into a Consulting Agreement requiring Synergem to provide the Client with a number of specified services. In accordance with the terms and conditions of paragraph 15 of the Agreement, the following change is hereby incorporated:

Modify Paragraph 6, Appendix A: Scope of Work as follows:

Add the following task:

6.9 In order to complete the new PSAP and serve the needs of the agencies it supports, it will be necessary to procure certain "commodity" components and systems for which a market price can be established by comparing competitor list prices or other similar information sources. It is more efficient and in the best interest of the county to purchase these items on the open market, as opposed to requesting vendor proposals. Consequently, Synergem is authorized to act as the county's agent in procuring these items. Synergem will act at the direction of the Director of Emergency Communications with the full concurrence of the Procurement Director. At no time will the cost to the county exceed the established market price for the item being procured. In addition, Synergem will be responsible for the installation, integration, testing, acceptance and maintenance and support of all the systems, components, programs and peripherals it procures. It may assess a reasonable fee for this service providing it declares this fee and the officials cited above consent in its assessment beforehand. Each procurement will be detailed in a document that describes the item being procured, its purpose and the derivation of the established market price. This document will include in its attachments a complete price and equipment list, scope of work statement, payment schedule and maintenance agreement (where appropriate). The officials named above will authorize these procurements by signing these documents.

By signing this order, Oconee County and Synergem hereby agree to amend the original Agreement as described herein. Unless amended by the terms outlined above, all other terms and conditions of the Agreement shall remain in full force and effect.

In addition to the components covered in the proposals, we will need, as a minimum to procure but not limited to the following items from the open market:

1. Console furniture for nine positions at about \$8K per position.	\$ 72,000*
2. Servers and other network components not included in LEC design.	\$180,000*
3. Workstations for nine positions including chairs at \$7K per position	\$ 63,000*
4. Digital fingerprint reader	\$ 70,000
5. Digital voice/logger	\$ 30,000*
6. LANs equipment	\$ 25,000†
7. E911 equipment and operating costs over five years	\$192,000*
8. Contingency (for those items that have not been identified or may be needed as a result of design needs)	\$ 75,000
TOTAL	\$617,000

* Can be paid for with 9-1-1 funds. It should be noted that the first demand on these funds is to meet the primary circuit alternate routing needs for 9-1-1 trunks and the software requirements for the CAD and the telephone system.





SUBJECT: Child/Elder Abuse Grant

The Oconee County Sheriff's Office is requesting County Council approval to apply for a grant that will allow our agency to dedicate an investigator to all child and elder abuse cases. The grant will be pursuant to the Federal Drug Control and System Improvement Formula Grant Program. The South Carolina Department of Public Safety, Office of Justice Programs, administers this program. The grant, if approved by the state, will pay 75% of program costs and will require a 25% cash match from the county.

It is well known that child abuse is a major problem in Oconee County as well as the rest of South Carolina and our nation. A less familiar problem is elder abuse, but mistreatment at any age is cause for great concern on the part of law enforcement. Since both areas of abuse impacts everyone at some point in their lives, both deserve specific attention.

Child abuse knows no socio-economic, educational or racial boundaries. The data on abuse and neglect cases reported by the Oconee County Department of Social Services provides a troublesome picture of this problem. In 2003, 50 cases of sexual abuse, 157 cases of physical abuse, 117 cases of physical neglect and 3 cases of medical neglect were reported. These 357 cases suggest to us that too many children are at risk of not growing up to become self-supporting adults, good family members, and responsible community citizens.

The primary purpose of this investigator is to improve the investigation of child/elder abuse cases through increased resources to improve coordination of the various agencies responsible for child/elder welfare, and to provide the victim's of these cases someone that will specialize in the area of child and elder abuse. A secondary purpose is to raise a preventive barrier in the effort to prevent further abuse by raising public awareness regarding these problems.

Currently, we have one investigator who investigates child abuse cases as well as all violent crimes in our county. This includes, murder, rape, armed robbery, aggravated assault and missing persons.

First year funding for this position to include all equipment, vehicle and office salary will be approximately \$89,875. The county cash match of 25% would be approximately \$22,469.
